In producing herewith one arrested accused person namely Gyan Bahadur Pradhan (60) s/o-Lt Dambar Pradhan of Salugara near Bengali High School PO-Salugara, w/n-42 PS-Bhaktinagar Dist-Jalpaiguri along with seized articles viz

- i) 13 bottles of King Fisher Strong Premium Bear each bottle containing 650 ml.
- ii) 27 bottles of MC Dowell's No-1 Celebration Rum each bottle containing 180 ml.
- iii) 08 bottles of Royal Blue Premium Whiskey each bottle containing 750 ml.
- iv) 31 bottles of Royal Celebration Special Whiskey each bottle containing 750 ml.
- v) 05 bottles of Officer Choice Deluxe each bottle containing 180 ml.
- vi) 03 bottles of Old Monk Deluxe each bottle containing 750 ml.

I SI.Biswajit Ghosh of Detective Department, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person to the effect that on 11.06.21 at 13.45 hrs received a secret source information that one person is illegally storing/selling ID liquor inside his house without any valid license .

The information was diarised vide D.D, SPC GDE No-83 Dt- 11.06.21 Accordingly I informed the matter to ACP,DD,SPC and as per his kind direction myself along with ASI.Praloy Bhattacharjee, Const- 371 Sushanta Dey, , Const-682 SK Sabrati, Const- 932 Pabitra Das and Const 945 Krishna Barman all of DD, SPC left for Salugara to verify the veracity of the source information. This refers D.D, SPC GDE No-84 Dtd- 11.06.21. On reaching at the spot at 14.35 hrs, on being identified by the source, our team cordoned the house of accused person and entered the house and found that the above mentioned person was selling ID liquor inside his house to his customers. On seeing our team the customers fled away but we managed to apprehend the above noted person i.e Gyan Bahadur Pradhan (60) s/o-Lt Dambar Pradhan of Salugara near Bengali High School PO-Salugara, w/n-42 PS-Bhaktinagar Dist-Jalpaiguri who was storing & selling ID liquors to his customers. On interrogation he disclosed his name and identity as noted above. On demand accused Gyan Bahadur Pradhan failed to produce any valid document or license from the appropriate authority for storing/selling liquor. He was running this business at his house illegally without any valid license. The accused person violated the provision of Bengal Excise Act. Accordingly, in presence of witnesses I searched the house of accused person and above noted ID liquor was found. Accordingly I seized the liquor from the possession of accused person under proper seizure list duly signed by the witnesses and accused person, seizure was made on 11.06.21 in between 14.55 hrs to 15.55 hrs. Label the seized articles

duly signed by the witnesses and accused person. I arrested the accused person preparing memo of arrest and intimated him the ground of arrest.

Hence, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Gyan Bahadur Pradhan (60) w/o Lt Dambar Pradhan of Salugara near Bengali High School PO-Salugara, w/o-42 PS-Bhaktinagar Dist-Jalpaiguri and arrange for its investigation.
