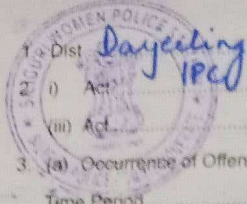

beg to inform you that my marriage was
solemnized under Hindu rites & rituals, nearly
two years back, with Smt. Mahato S/o Late
Ajit Mahato, resident of Near Ramghat, Natar
pura, Ward No. 5 SMC, P.O. Siliguri Bazar, P.S.
Siliguri, Distt - Darjeeling, but since after my
marriage, my said husband & his mother namely
Smt. Rita Mahato w/o late Ajit Mahato of note
noted address started subjecting me for physical
& mental cruelty for demand of dowry.

On St. 07.06.2021 at about 03.00 pm,
when I was at my matrimonial home at near
Ramghat, Natarpura, at that time my said
husband & his relatives namely (1) Smt. Mahato
S/o late Ajit Mahato & (2) Smt. Rita Mahato w/o
late Ajit Mahato & (3) Smt. Kanchan Mahato
w/o Sri Bittu Mahato, all are of near Ramghat
Natarpura, Ward No. 5 SMC, P.O. Siliguri Bazar
P.S. Siliguri, Distt - Darjeeling, demand Rs. 05
(five) lacs rupees as dowry, neither leave my
matrimonial home and when I called my parents
namely, (1) Sundar Kanti S/o late Kailu Kanti
& (2) Smt. Gita Devi Kanti w/o Sri Sundar Kanti
and they resided at my matrimonial home,
the above named my husband & his relatives
started abusing my parents in filthy language
and when my parents denied to pay him
said amount as dowry, thereafter they kicked
me and my minor son (14 months old) from
my matrimonial home and now I am residing
at my parental home at Santosh Nagar,
with my infant son.

So please take necessary action against
my said husband & his above named mother
& sister.
