With due regards, I, SMT. SUPRIYA PAUL (GHOSH), Wife of Sri Partha @ Bapi Ghosh, Daughter of Sri Swapan Kumar Paul, Presently residing at C/O Manti Sweets, Khelaghar More, Hakim Para, Ward No. № 16 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint to the effect that and my marriage was solemnized on 12.12.2004 with Sri Partha @ Bapi Ghosh, Son of Late Nripen Ghosh of Hakim Para, Rash Behari Sarani, Siliguri according to the Hindu Rites and Customs. It is to be mentioned here that our marriage was the outcome of our previous love and affairs and after my ASI.N. C. Les marriage, I along with my husband have live together as husband and for its my matrimonial house and after staying one month, we have shifted in a rented premises and started to reside there at Rabindra Nagar, Near Basic School, Siliguri and out of our lawful wedlock, one female child was born on 16.01.2006 whose name is Miss Ankona Ghosh mspector in Charge my said daughter is now studying in Class – X at Jermals Academy.

Siliguri Police Complication and Management is now studying in Class – X at Jermals Academy. upon me both physically and mentally on the demand of more dowry. My husband is a habitual drunker and he used to consume alcohol on regular basis and even during the period of my pregnancy also, my husband after consuming alcohol, inflicted torture upon me both physically and mentally and being a lady of middle class Hindu family, I used to borne all such type of inhuman torture of my husband and it was my presumption and hope that after delivery of the child, he might have change and thereby, rectify himself but all my hopes have gone in vain due to the continuous torture of my husband upon me. Not only that, my husband has been maintaining adulterous and extra marital relation with so many young girls and women and due to his continuous torture upon me, I have compelled to lodge a written complaint before the O.C. Bhaktinagar P.S. and a case U/S 498A of I.P.C. has been registered against my husband and immediately after initiation of the said case, my husband and his family members came before me and my

family members and confessed his guilt and also assured me and my family members that in future, he will not commit any type of torture upon me and after receiving such type of assurance from my husband and his family members, I again started to reside with my husband as husband and wife and withdraw the said case pending against my husband. Immediately after withdrawal of the said case, my husband has return back towards his earlier attitude and behavior and started to inflict torture upon me. Thereafter, we have purchased a flat and garage at Sanghati More, in the Ground Floor of Prakriti Apartment with the financial assistance of my father and the L.I.C.I. Home Loan and we have also booked one shop room at Haider Para, Near Budha Bharati School. On 01.08.2017, I have purchased a lottery ticket of Dear Parrot and I have own the first prize amounting to Rs. 61,00,000/- only and thereafter, I have claimed the amount against the said draw of lottery and accordingly, an amount of Rs. 42,70,000/- only after deducting the GST and other charges, transferred in my account singly operated by me lying at The South Indian Bank Ltd., Sevoke Road Branch, Siliguri being Account No. 0828053000000664 and after winning the said prize, my husband took a sum of Rs. 90,000/- only from me and fled away with a girl namely Dipshita @ Rima Das leaving me and my daughter and started to reside with the said girl and in the Facebook, he posted some photos in his facebook profile with the said girl namely Dipshita @ Rima Das wherein he also make comments that the said girl is his wife and even during the period of residing with the said lady, he used to come to me every after two or three months and asked me to pay amount to him from my said account where, I kept the amount of the lottery winning prize and due to fear, I used to pay amount as per his demand. Thereafter, my husband started to create pressure upon me to put his name in the said account of The South Indian Bank Ltd. in the said Bank Account No. 0828053000000664, so that, he can also operate the said account as per his desire and under compulsion, pressure and threat, I have compelled to put his name in the said account and after joining the name in said account, my husband misused huge amount of money from the said account in order to fulfill his ill desire and whenever I raised my voice against his such type of illegal acts, he did not bother to assault me physically for which, I received severe injury on several occasion. My husband did not bother to take care upon our minor

daughter also and his only aim to squeeze money non-my sees necesses Sir, I have purchased a four wheeler Maruti Alto 800 LXI vehicle vide Reigstration No. WB74-AT-2175 in my name in the year of 2018 and immediately after purchasing the said vehicle, he took the possession of the said vehicle forcibly from me and since last two years, I could not see my own vehicle and I heard that my husband keeping mortgage my said vehicle before the private person, took a huge amount of money though, he has no right, title and interest in and over the said vehicle and as and when, I asked him about the said vehicle, he falsely stated me that due to some mechanical problem, he placed the vehicle in the garage and after repairing the same, he will produce the vehicle but till today, he failed to produce the vehicle before me and considering his attitude and behavior, on 10.06.2021, I went to the Branch of The South Indian Bank Ltd. at Sevoke Road, Siliguri for transferring a sum of Rs. 8,00,000/only from the said account to my another account lying in the same branch and hearing the same, my husband came before me and assaulted me physically and thereafter, he submitted one objection before the Bank Authority for not transferring the amount from the said account and due to the said objection, the said amount is still kept in the joint account. Thereafter, my husband and his family members came before my parental house and abused and threatened me and my family members with dire consequences in order to extort money from my said account and my husband also threatened me by saying that if I do not agree to give the 50 % of the amount lying in the said account, he will destroy my life and property and after receiving such type of threatening from my husband, I have been passing my days with extreme fear and anxiety.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband as per the provision of law and obliged thereby.
