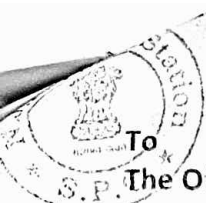

Sir,

In producing herewith one accused person namely Shyamal Debnath (31) S/O Lt. Anil Ch. Debnath of Nawapara, PO-Sahudangi hat, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Five (05) Bottles of Imperial blue Authentic Grain Whisky 375 ml. each.
2. Two (02) Bottles of Royal Stag Premier whisky 375 ml. each.
3. Fifteen (15) bottles of Pet Galaxy Boss 60° UP Country Spirit 600 ml. each.

I, SI Rakesh Debnath of Ambari Falakata out post under NJP PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 12.06.2021 at 06.15 hrs received a source information that one Shyamal Debnath (31) S/O Lt. Anil Ch. Debnath of Nawapara, PO-Sahudangi hat, PS-NJP, Dist- Jalpaiguri has gathered huge amount of liquor illegally at his residential house for selling the same to the customer for his wrongful gain. This refers to Ambari Falakata out post GDE no-454 dated 12.06.21. Accordingly, I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, SI Kamal Ch. Saha, C/ 505 Tapash Dutta, C/ 1058 Jayanta Debnath, C/975 Swarup Basak, NVF/159 Debranjana Sarkar proceed to Nawapara to work out the information. At 06.35 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Shyamal Debnath and recovered the above noted articles from the possession of above noted accused person namely Shyamal Debnath (31) S/O Lt. Anil Ch. Debnath of Nawapara, PO-Sahudangi hat, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Subhas Sarkar S/o Lt Narayan Sarkar of Mahamaya colony PS-NJP Dist-JPG. 2) Rabi Thapa S/O Ramesh Thapa of Durgaguri, PS-Pradhanagar Dist-Darjeeling, I have seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took his signature and witnesses. The seizure was made between 07.05 hrs to 07.25 hrs. Hence, I have arrested the said accused person u/s 41 Cr.P.C. after issuing Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore, request you a specific case may kindly be started against the accused person namely Shyamal Debnath (31) S/O Lt. Anil Ch. Debnath of Nawapara, PO-Sahudangi hat, PS-NJP, Dist- Jalpaiguri under proper section of law.
