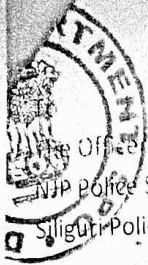

Sir,

In producing herewith one arrested accused person namely Gautam Mandol (30) s/o-Gouranga Mandol of Ambari Chakia Vita, PO-Kamarvita, PS-NJP, Dist-Jalpaiguri along with seized articles viz

- i) 19 bottles of MC Dowell's No-1 Celebration Rum each bottle containing 180 ml.
- ii) 44 bottles of Royal Stag Whiskey each bottle containing 375 ml.
- iii) 06 bottles of Himalayan Gold Country Spirit 60 UP each bottle containing 600 ml.
- iv) 34 bottles of Royal Choice Country Spirit each bottle containing 300 ml.

I SI Swadesh Saha of Detective Department, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person to the effect that on 12.06.21 at 17.15 hrs received a secret source information that one person is illegally selling ID liquor inside a grocery shop at Ramkrishna Para, Madani Bazar under NJP PS without any valid license.

The information was diarised vide D.D, SPC GDE No-89 Dt- 12.06.21 Accordingly I informed the matter to ACP, DD, SPC and as per his kind direction myself along with ASI Prabin Chettri, Const-682 SK Sabrati, Const- 932 Pabitra Das and Const-945 Krishna Barman all of DD, SPC left for Ramkrishna Para, Madani Bazar under NJP PS to verify the veracity of the source information. This refers D.D, SPC GDE No-90 Dtd- 12.06.21. On reaching at the spot at 18.00 hrs, on being identified by the source, our team cordoned the grocery shop and entered the shop and found that the above mentioned person was selling ID liquor from inside the grocery shop to the customers. On seeing our team the customers fled away but we managed to apprehend the above noted person i.e Gautam Mandol (30) s/o-Gouranga Mandol of Ambari Chakia Vita, PO-Kamarvita, PS-NJP, Dist-Jalpaiguri who was selling ID liquors to the customers. On interrogation he disclosed his name and identity as noted above. On demand accused Gautam Mandol failed to produce any valid document or license from the appropriate authority for selling liquor. He was running this business at Ramkrishna Para, Madani Bazar illegally without any valid license. The accused person violated the provision of Bengal Excise Act. Accordingly, in presence of witnesses I searched the grocery shop of accused person and above noted ID liquor was found. Accordingly I seized the liquor from the possession of accused person under proper seizure list duly signed by the witnesses and accused person, seizure was made on 12.06.21 in between 18.05 hrs to 18.55 hrs. Label the seized articles duly signed by the witnesses and accused person. I arrested the accused person preparing memo of arrest and intimated him the ground of arrest.

Hence, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Gautam Mandol (30) s/o-Gouranga Mandol of Ambari Chakia Vita, PO-Kamarvita, PS NJP, Dist-Jalpaiguri and arrange for its investigation.
