Accordingly, I seized the above noted I/D liquor from the possession of accused Jiten Sha (37 yrs) S/O Ramnath Sha of D.S. Colony, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.45 hrs to 21.15 hrs on 12.06.21.
