Sir,

With due respect, I am producing herewith the arrested accused person namely Jiten Sha (37 yrs) S/O Ramnath Sha of D.S. Colony, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

5. 35 (thirty five) bottles of 60 up Himalayan Gold Country Spirit containing 650 ML in each bottle of-Rs 100/- of each bottle.
6. 01 (One) bottle of IMPERIAL BLUE Cloassic grain Whisky contining 375 ML of MRP Rs 360/-

I beg to state that today i.e. on 12.06.21 at 20:15 hrs I received a secret source information that one person named Jiten Sha of D.S. Colony, NJP is selling ID liquor illegally at his shop at D.S. Colony for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 584 dated 12.06.21 and informed the fact to you. As per your kind direction and instruction myself along with C/1053 Paresh Rava and CV/824 Niru Kr Yadav All of NJP PS, SPC left for D.S. Colony to work out the information in hand. At about 20.35 hrs we arrived at D.S. Colony and being shown and identified by the source we held raid at the shop of accused Jiten Sha (37 yrs) S/O Ramnath Sha of D.S. Colony, PS- NJP, Dist.- Jalpaiguri and managed to intercepted him. During interrogation he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his gain. since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Jiten Sha (37 yrs) S/O Ramnath Sha of D.S. Colony, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.45 hrs to 21.15 hrs on 12.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Jiten Sha (37 yrs) S/O Ramnath Sha of D.S. Colony, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
