Sir,

With due respect, I am producing herewith the arrested accused person namely Sanjoy Barman (29 yrs) S/O Biren Barman of Santi Para, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 31 (Thirty) bottles of 60 up Himalayan Gold Country Spirit containing 650 ML in each bottle of Rs 100/- of each bottle.
2. 05 (Five) bottles of KINGFISHER Strong premium Beer containing 650 MI in each bottle of MRP Rs 130/- of each bottle.
3. 07 (Seven) numbers of paper made pouch of Officer Choice Deluxe Whisky containing 180 ml in each pouch of MRP Rs 140/- in each pouch.
4. 02 (two) bottles of Sterling Reserve Whisky containing 180 MI in each bottle of MRP Rs 204/- of each bottle.

I beg to state that today i.e. on 12.06.21 at 20.25 hrs I received a secret source information that one person named Sanjoy Barman (29 yrs) S/O Biren Barman of Santi Para, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Gate Bazar for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 585 dated 12.06.21 and informed the fact to you. As per your kind direction and instruction, myself along with CV/116 Rohit Kr Mahato and VP/13 Jamirul Islam VP/08 Laxman Roy All of NJP PS, SPC left for Gate bazar to work out the information in hand. At about 20.40 hrs we arrived at Gate Bazar and being shown and identified by the source we held raid at the house of accused Sanjoy Barman (29 yrs) S/O Biren Barman of Santi Para, PS- NJP, Dist.- Jalpaiguri and managed to intercepted him. During interrogation he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Sanjoy Barman (29 yrs) S/O Biren Barman of Santi Para, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.55 hrs to 21.15 hrs on 12.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sanjoy Barman (29 yrs) S/O Biren Barman of Santi Para, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
