I S.I. Krishna Ch. Mandal of Matigara P.S do hereby lodge a Complaint to the effect that on 12.06.2021 at 13:55 hrs I received a information from reliable source that one vehicle Dumper bearing Reg. No. WB - 73 D 8575 loaded with stolen river bed materials coming from Shivmandir side . On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at near Shivmandir under Matigara P.S area, I found said Dumper bearing Reg. No. WB - 73 D 8575 loaded with river bed materials going towards Matigara. Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area. As such I seized the above noted loaded truck under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle and the seized vehicle without number plate under proper section of law and arrange for its investigation.
