1. 09 (Nine) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.)  
marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as  
Exhibit "A-1",
2. 05 (Five) bottles of Mc Dowell's No Celebration Matured XXX Rum (each bottle containing  
180 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and  
marked as Exhibit "B-1",
3. 04 (Four) bottle COSMOS Fifty (each bottle containing 750 ml.) marked as Exhibit "C" from  
which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
4. 06 (Six) bottle King Fisher Beer (each bottle containing 750 ml.) marked as Exhibit "C" from  
which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
5. 01 (One) container containing five litters Local Made Chullu marked as Exhibit "D" from  
which 01 litter randomly taken out as sample and marked as Exhibit "D-1",

I, ASI Dharendra Nath Mandal of Bagdogra Police Station, SPC do hereby lodged this complaint against  
the above noted arrested person named Prakash Sharma 32yrs to the effect that today i.e., on 15.06.21  
at about - 19.35 hrs received source information that one person who carry huge quantity of illicit liquor  
at Airport more for his village area *some of his designated customers*. Accordingly I shared the  
information with you and diarized the fact vide GDE no 764 and as instructed had been to Airtort More  
under Bagdogra PS, to work out the information. On reaching there at about 19.50 hrs, I contacted with  
my source and subsequently being pointed apprehended the above noted person who carry one nylon  
bag with his hand on search the above noted illicit liquor has been recovered from his bag on being  
asked disclosed his identity as noted above and stated that he is selling illicit liquor from his house *some*  
of his designated customers since long on demand he failed to produce any valid documents/papers in  
support of possessing and carrying of the liquor and further admitted that he is involved in such trade for  
last few months. Accordingly, I seized the above noted illicit liquor found under proper seizure list in  
presence of witnesses and labelled and also arrested him issuing memo of arrest. The whole process of  
seizure and labelled was made in between 20.05 hrs to 20.45 hrs.


Therefore, I pray that a specific case under proper section of law may kindly be recorded against
