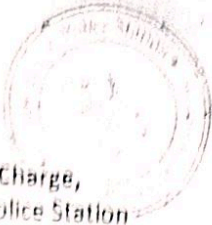

Sir,

In producing herewith the accused persons namely 1) Bharat Das (35), S/O Lt. Foni Das Of Darjeeling more, Rajibnagar, P.S. Pradhannagar, Dist. Darjeeling, 2) Ujjal Tamang (20), S/O Lt. Prajan Tamang Of Balason TE. W/No 15, Sonada, P.S. Jorebanglow, Dist.- Darjeeling, 3) Dipesh Chettri (21), S/O Vim Chettri of Thakurbari, mainroad, P.S. & Dist. Kalimpong, in custody and the following property under seizure along with seizure list (i) 39 (thirty nine) nos "LEEGESIC" injections contains 2ml each marked as "Exhibit A", which was kept in white colour small size plastic packet, (ii) 01 (one) "LEEGESIC" injection taken from "Exhibit A" for examination marked as "Exhibit A1", (iii) 39 (thirty nine) nos of "Diazelab" injections contains 2ml each marked as "Exhibit B", which was kept in black colour small size plastic packet, (iv) 01 (one) "Diazelab" injection taken from "Exhibit B" for examination marked as "Exhibit B1", (v) 39 (thirty nine) nos of "PHENERGAN" injections containing 2ml each marked as "Exhibit C", which was kept in green colour small size plastic packet, (vi) 01 (one) "PHENERGAN" injection taken from "Exhibit C" for examination marked at "Exhibit C1", as per seizure list (Total No of Injections 117). The above noted articles seized as alamat of the case.

I, ASI Debasish Das of Pradhannagar Police station, SPC do hereby lodged this complaint to the effect that on 14.06.2021 at 23.40 hrs received an information from my secret source that three persons are standing at Rajib nagar, Near Darjeeling more with huge quantity of illegal contraband injections in their possession for the purpose of selling/distributing at different places at Siliguri area. Accordingly I shared the information with you and as per your kind direction, at 23.50 hrs myself along with, ASI Ratan Pradhan, ASI Ashit Singha, CV/223 Swapan Chettri, CV/128 Ajay Kumar Sahani, CV/131 Ranjan Sharma, CV/646 Baban Chandra Das all of Pradhannagar P.S. left for Rajib nagar to verify the veracity of information diarised vide PDH P.S. GDE. No. 765, Dtd. 14.06.2021. At about 23.55 hrs myself along with party reached at the spot. Due to lockdown issued I could found any independent witness to keep them during the operation. After confirmed by the source I managed to apprehended the above noted 03 persons. After disclosed out identity, I searched them and from the possession of the said apprehended persons I recovered (i) 39 (thirty nine) nos "LEEGESIC" injections contains 2ml each marked as "Exhibit A", which was kept in white colour small size plastic packet, (ii) 39 (thirty nine) nos of "Diazelab" injections contains 2ml each marked as "Exhibit B", which was kept in black colour small size plastic packet, (iii) 39 (thirty nine) nos of "PHENERGAN" injections containing 2ml each marked as "Exhibit C", which was kept in green colour small size plastic packet. On demand they could not produced any documents in respect of the said recovered contraband injections. On interrogation they disclosed that they was carrying the recovered contraband injections without any documents with a view to sell the same to their different customers for their illegal gain. Thus I seized the recovered injection under proper seizure list. The seizure was made on 15.06.2021 at between 00.35 hrs to 01.50 hrs. Accordingly I arrested the above noted accused persons under proper memo of arrest. At 02.25 hrs myself along with force brought the arrested accused persons at Pradhan nagar P.S. vide GDE NO 768, Dated- 15.06.2021.

Hence it is prayed that a specific case may kindly be started against the accused persons namely 1) Bharat Das (35), S/O Lt. Foni Das Of Darjeeling more, Rajibnagar, P.S. Pradhannagar, Dist. Darjeeling, 2) Ujjal Tamang (20), S/O Lt. Prajan Tamang Of Balason TE. W/No 15, Sonada, P.S. Jorebanglow, Dist.- Darjeeling, 3) Dipesh Chettri (21), S/O Vim Chettri of Thakurbari, mainroad, P.S. & Dist. Kalimpong and arrange for its investigation.
