Mingma Sherpa of Lebung, P.S - Sadar, Dist - Darjeeling, (ii) Rohit Rai (36), S/O Bhira Rai of Lebung, P.S - Sadar, Dist - Darjeeling, (iii) Barun Pradhan (26), S/O Kiran Pradhan of Lebung, P.S - Sadar, Dist - Darjeeling, (iv) Aditya Pradhan (24), S/O Deepak Pradhan of Lebung, P.S - Sadar, Dist - DJG , arrested u/s 41 Cr.P.C.

I, S.I. Newton Biswas of Matigara P.S SPC to the effect that on 14.06.2021 in course of Special Mobile Van duty he found four persons namely (i) Chiten Sherpa (29), S/O Lt.
