Ilyas Islam, resident of Gandhi Nagar, Ward No.43 of S.M.C., Post Office- Sevoke Road, Police Station- Bhaktinagar, District - Jalpaiguri, do hereby lodged a complaint against Santosh Sah, Son of Not Known, Suraj Sah and Suren Sah, both are son of Santosh Sah, all are resident of Sahid Nagar, Ward No.43 of S.M.C., Post Office- Sevoke Road, Police Station- Bhaktinagar, District - Jalpaiguri, to the effect that on 13-06-2021 at about 5:00 P.M. when I along with my brother Md. Ramjani and Md. Saddam was having tea at tea shop nearby my house at Sahid Nagar More, seeing us said Santosh Sah, Suraj Sah and Suren Sah came at the tea shop and threatened us not to make "ADDAA" in the tea shop and when we told them that we have come here to have a tea then they physically assaulted my brothers and when I went to rescue my brother from their assault, they assaulted me with fists and blows and hit me with stick on my head and snatched away my gold chain and Rs.10,000/- from my possession.

Due to said physical assault by them, I sustained head injury and was taken to the Siliguri District Hospital by my aunty for my treatment.

So, therefore, I humbly request you to take necessary legal action against the said persons at an earliest.
