Sir,

With due respect, I am producing herewith the arrested accused person namely Biswanath Roy (25 yrs) S/O Joydeb Roy of Madani Bazar, Baribhasa, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 20 (Twenty) pcs of DIAZEPAM INJECTION IP containing 2 ml in each injection of MRP RS 12.30/- of each injection.
2. 28 (Twenty eight) pcs of Promethazine Hydrochloride Injection IP containing 2 ml in each injection of Rs 9.18/- of each injection.
3. 27 (Twenty seven) pcs of Burenorphine Injection IP containing 2 ml in each injection of MRP Rs 20.30/- of each injection.
4. 09 (Nine) pcs of DIAZEPAM INJECTION, IP Diazelab containing 2 ml in each injection of MRP Rs 13.52 of each injection.

I SI Goutam Mallik of NJP PS under your kind control beg to state that today i.e. on 13.06.21 at 18.30 hrs I received a secret source information that one person named Biswanath Roy of madani Bazar is selling illegal drugs without any Doctors prescription at Lake Town area for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 631 dated 13.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, VP/13 Jamrul Islam and VP/08 Laxman Roy left for Lake Town, NJP to work out the information in hand. At about 18.55 hrs we arrived at Lake Town, NJP and being shown and identified by the source we held raid at Lake Town and managed to apprehended one person with a bag in his right hand. On being asked he disclosed his name and identity as Biswanath Roy (25 yrs) S/O Joydeb Roy of Madani Bazar, Baribhasa, PS- NJP, Dist.- Jalpaiguri and also disclosed that he is selling contravant drugs/injection to the young guyes at Lake Town area since long for his illegal gain. On search the above noted contravant drugs/injection recovered from his possession which was kept in the bag. On demand he failed to produce any documents/licence for selling contravant drugs/injection which has been found in his possession. On interrogation he admitted his guilt and disclosed that he is selling contravant drugs at Lake Town area for his wrongfull gain. Accordingly, I seized the above noted contravant drugs/injection from the possession of accused Biswanath Roy (25 yrs) S/O Joydeb Roy of Madani Bazar, Baribhasa, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.25 hrs to 21.35 hrs on 13.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Biswanath Roy (25 yrs) S/O Joydeb Roy of Madani Bazar, Baribhasa, PS- NJP, Dist.- Jalpaiguri bvfiffand arrange for its investigation.
