Dear Sir,

This is to inform you that we had sold goods to M/s. Saha & Co., Kolkata vide Invoice No. SAMPL/0323 Dated 11.06.2021 (e-Way Bill No. 881161755064) & Consignment Note No. 569 Dated 11.06.2021 loaded on Vehicle No. WB11E6121. The vehicle was provided to us by Bithika Road Lines from Siliguri. The vehicle was loaded in our premises located at Plot Nos. 25(F) & 34(P), Dabgram Industrial Growth Centre, P.O. Satellite Township, Dist. Jalpaiguri-734015. The owner of the vehicle is Mr. Sarju Kumar Keshri, son of Mr. Lakhsman Kesari (Mobile No. of Vehicle Owner: 8777534933). The vehicle's driver name is Abul Kader, son of Ajimuddin having Driving Licence No. AS16 20160020094 (Mobile No. of Driver: 6000825277). The Vehicle was supposed to reach to Kolkata by Tuesday, dated 15.06.2021. But the vehicle is missing with entire goods loaded on it. We inquired to the transporter and the vehicle owner about the status of the vehicle. They were also unable to trace the vehicle. In the meantime, the owner of the vehicle informed us that the vehicle has last crossed Guabari Toll towards Assam at 01:02 AM on 12.06.2021. The owner of the vehicle is also not able to trace the vehicle and driver. We suspect that we have been cheated by the driver and the owner of the vehicle and there is breach of trust by them. We have been cheated and now the vehicle is not being traceable at all. So, we request your honour to investigate into the matter and trace our Goods.
