In producing herewith one accused person namely Arjun Sutradhar (M/28), S/o- Atul Sutradhar of Balarampur, Sholdukri, PS- Tufanganj, Dist- Coochbehar along with the following seized articles under seizure as per seizure list:

3. 10 (ten) sacks wooden dust.

I, SI Ajay Pradhan of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that on today i.e 15.06.2021 during my mobile van duty, at 18.20 hrs, received a specific source information that one person would be coming from Coochbehar side to Siliguri a suspected consignment of Ganja in a small pick up van bearing registration no. WB 73 D/ 3071. Accordingly I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, SPC and requested him to strengthen by more police personnel at Jatiakali area. Hence, he diarized the fact in GDE vide NJP PS GDE No 717, Dated- 15.06.21 and at 18.25 hrs himself along with ASI Khagen Barman, C/1053 Paresh Rava, CV/30 Biswajit Roy, CV/116 Rohit Mahato all of NJP PS left PS for Jatiakali area under NJP PS vide M.C.C. No 1485/21, Dated- 15.06.21 to verify the veracity of the information vide GDE No 717 dated 15.06.2021

Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 18.45 hrs we reached at Jatiakali and parked the vehicle at considerable distance and proceeded towards Jatiakali. Meanwhile, I called two disinterested witnesses namely 1) Jahangir Alaam (M/32), S/o- Yanul Haque of Kamranga Guri, PS- NJP, Dist. Jalpaiguri and 2) Surojit Saha (M/37), S/o- Lt. Arun Ch Saha of I.O.C. Gate, Janata Para, PS- NJP, Dist. Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any. Meanwhile, our Police party started looking for accused person and finally one vehicle bearing registration no. WB 73 D/ 3071 coming towards Jatiakali from Jalpaiguri side. We stopped the vehicle and asked the driver to park the car beside the road. I disclosed our identity to him. On being asked he disclosed his name and address as noted above and about the information he denied that but after interrogation, he admitted that there is Ganja in a special chamber in the vehicle which was loaded with the 10 (ten) plastic sacks of 'Wooden Dust'. I then, gave them option that whether he wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer. He agreed to be searched in presence of police Gazetted Officer. Accordingly, I served the Notice in writing as per provision of law to him which he duly acknowledged by receiving and signing in the copy of Notice. Accordingly, I informed Shri. Shubhendra Kumar, IPS, ACP East-I, SPC rewarding the apprehension of said persons with said to be Ganja and requested him through messenger to come at Jatiakali, NJP and remain present as Gazetted Officer during the time of search and seizure if any which he duly accepted. At 19.45 hrs Shri. Shubhendra Kumar, IPS, ACP East-I, SPC, arrived at the spot in uniform and disclosed his identity to the detained person as well as witnesses as a Gazetted Officer, Shri. Shubhendra Kumar, IPS, ACP East-I, SPC. I also offered the independent witnesses and the accused person to search me and our Police Party as per provision of law. But he refused to search the police party. Under the supervision of Shri. Shubhendra Kumar, IPS, ACP East-I, SPC, and in presence of independent and disinterested public witnesses I searched the detained persons physically following all formalities keeping decency but nothing could be recovered on their persons except wearing apparels. Then, I, in presence of witnesses and under the supervision of Shri. Shubhendra Kumar, IPS, ACP East-I, SPC, searched the vehicle which was loaded by 10 sacks of 'Wooden Dust' and found 28 (twenty eight) packets wrapped by black colour plastic said to be Ganja. On demand, in presence of the Gazetted Officer Shri. Shubhendra Kumar, IPS, ACP East-I, SPC, he failed to produce any valid document in support of possessing/procurement of said to be Ganja which were kept inside the special chamber of the vehicle with a intention for sale the same at Bihar state.

I, accordingly, weighed the said to be Ganja by Digital weighing instrument taken by us and found total 156 (one hundred fifty six) Kgs said to be Ganja in 28 (twenty eight) separate packets and marked as Exhibit- A, Exhibit- B, Exhibit-C, Exhibit-D, Exhibit-E, Exhibit-F, Exhibit-G, Exhibit-H, Exhibit-I, Exhibit-J, Exhibit-K, Exhibit-L, Exhibit-M, Exhibit-N, Exhibit-O, Exhibit-P, Exhibit-Q, Exhibit-R, Exhibit-S, Exhibit-T, Exhibit-U, Exhibit-V, Exhibit-W, Exhibit-X, Exhibit-Y, Exhibit-Z, Exhibit-AA and Exhibit-AB, 10 (ten) sacks wood dust and one Bolero Pick up bearing Regt. No. WB73D 3071. Accordingly, I seized, sealed and labelled the entire article in presence of Shri. Shubhendra Kumar, IPS, ACP East-I, SPC and independent witnesses and accused person which was acknowledged by the accused person. The search, seizure and labelling was made between 19.55 hrs to 21.25 hrs. Then, I arrested the above noted accused person after observing all guidelines of Apex court of arrest, as he violated the provisions of Narcotic Drugs by possessing said to be Ganja without any valid authority, document or license. On interrogation the accused person as noted above, admitted that he procured the said to be Ganja from Coochbehar side for the purpose of making money illegally.

Under the above circumstances, I pray, to you that a specific case under proper section of law may kindly be started against the accused person namely Arjun Sutradhar (M/28), S/o- Atul Sutradhar of Balarampur, Sholdukri, PS- Tufanganj, Dist- Coochbehar and arrange for its investigation.
