In producing herewith six 08 (eight) persons who disclosed their name & identity as (i) Joydeb Choudhury (31yrs) S/O- Dinabandhu Choudhury of Tinbatti Jyotirmoy Colony, PS-NJP, Dist- Jalpaiguri, (ii) Raju Das (28yrs) S/O- Lt. Mani Chadra Das of Bagrakote, Jyotinagar Colony, Ward No-20, PS-Siliguri, Dist-Darjeeling, (iii) Sabir Mandal (19yrs) S/O- Piyaruddin Mandal @ Shuku of Jhankarmore, Tumulpara, Ward No-4, PS-Siliguri, Dist-Darjeeling, (iv) Rabiul Rahaman (20yrs) S/O- Sariful Rahaman of Samar nagar, Battola, PS-Pradhan Nagar, Dist-Darjeeling, (v) Ratan Das (42yrs) S/O- Raghu Nath Das of Uttar Bharat Nagar, near Sramik Nagar, PS-Siliguri, Dist-Darjeeling, (vi) Rabi Das (43yrs) S/O- Radha Charan Das of Sukantapally, Milanpally, PS-Siliguri, Dist-Darjeeling, (vii) Chiranjit Mandal (28yrs) S/O- Lt. (i) Toto green colour bearing No. WB 73F/6824 (ii) Toto blue colour bearing No- WB 73F/6821 (iii) Toto red colour without (iv) Toto green colour without number (v) Toto red colour bearing No- WB 73F/4688, (vi) Toto red colour without number (vii) Toto yellow colour without number (viii) Toto deep blue colour without number. I, SI Uttam Kumar Ghosh of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 15.06.2021 at 12.45 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons. All the above noted persons were roaming with their TOTOs noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
