I, **SRI SANTU DEVNATH**, son of Nirmal Devnath, resident of, Baghajatin Colony, Ward No 45 of Siliguri Municipal Corporation, Post Office & Police Station Pradhan Nagar, District Darjeeling, PIN Code 734003 would like to inform you that I am the constituted attorney of Sri Ranjit Biswas, son of Late Jyotish Ch. Biswas resident of Mohorgaon, P.O. Gulma , P.S. Pradhan Nagar, Dist. Darjeeling who is the actual and recorded owner of the below schedule land. Few months ago Manager of Chandmoni Tea Estate and some labors of the tea estate tried to encroach the below schedule land. He lodged a written complaint with the Officer-in-Charge, Matigara Police Station against the said persons. He also filed an application U/S 144 of Cr. P.C. against (1) Chandmoni Tea Estate, (2) Manager of Chandmoni Tea Estate and (3) Public-in General before the Ld. Special Executive Magistrate, Siliguri Police Commissionarate, Siliguri being Petition Case No. 81/2020 and the said case is still pending before the Ld. Court. On 10/06/2021 at about 10.30 A.M. one Bablu Bala of residents of Ujanu, P.S. Matigara, Dist. Darjeeling along with some others are stop construction work the below schedule land, destructed some portion of boundary wall and stolen about 20 bags cements, rod and other materials. They beat my labors and mansions with rod, lathi etc. After knowing the incident when I rushed to the spot they resist me to enter into the land. They threatened me with dire consequence that if I again visited the said land, then they shall kill me. I became naturally

alarmed. I further told them that Sri Ranjit Biswas is the actual and lawful owner of the land. The said persons became very hostile towards me and threatened me with dire consequences if I dared to resist them in any manner whatsoever. In a very adamant and hostile manner the said persons hurled filthy abuses at me and even threatened to kill me. Sir, being helpless man I was compelled to leave the place in the face of such threats. The above noted persons are very dangerous in nature. Finding no other alternative I am taken shelter of your good self.

Under the above circumstances I hereby requesting you to kindly inquire in to matter immediately to protect the below schedule and can no harm is caused to the property by the miscreants as aforesaid. I would also request you to take appropriate legal action against the above noted miscreants for indulging in such illegal and nefarious activates.
