Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Lakhan Roy (38), (ii) Sakin Singh (25), (iii) Bikah Ranjan Ojha (29), (iv) Nakul Singha (37), (v) Mohammad Sarwar Alam (27), (vi) Janardan Yadav (34) & (vii) Md. Usman (30) under proper section of law and arrange for its investigation.
