In producing herewith 04 (Four) arrested accused persons U/s 41 Cr.P.C who disclosed their identity as (1) Rohit Paswan (27 Yrs) S/o Prakash Paswan of D.S.Colony, PS- NJP, Dist- Jalpaiguri (2) Intaj Alam (31 Yrs) S/o Late Mohiraddin of Kadobari, PS- Kotwali, Dist- Jalpaiguri (3) Anupam Dasgupta (52 Yrs) S/o Late Dipendra Narayan Dasgupta of Jamurivita, PS- NJP, Dist- Jalpaiguri (4) Maru Mandal (35 Yrs) S/o Late Sanatan Mandal of South Colony, PS- NJP, Dist- Jalpaiguri.

I, ASI Arannya Binay Das of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that on 14/06/21 while performing QRT mobile duty in vide GDE No 657 Dtd. 14/06/21 and Spl. C.C No 1475 /21 dtd. 14/06/21, I along with forces had been to Saktigarh, area, in between 15:25 Hrs and 19:15 Hrs and found that the above noted persons were gathered there without any reason and found them without wearing mask also making unnecessary gathering at Saktigarh, area. On being asked the above noted persons stated before me that they were well aware of Govt. order regarding pandemic situation of Covid-19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 15:25 Hrs and 19:15 Hrs duly signed by them in presence of witnesses inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
