With due respect I Smt.Manisha Goyal W/O Kamal Agarwal(Mittal) D/O Sri. Dwarka Goyal Presently residing at Agrasen Road, Khalpara, Siliguri would like to draw your kind attention to the following effect that I was previously married and I have one daughter of the said marriage namely Navya Goyal (9 years old) but said marriage was dissolved on 2nd January 2014 by mutual consent of both parties there after I was resided with my parents but since the month of February 2021 my neighbour Anandi Kedia and C.A. Mr.Rajesh Agarwal convinced me as well as my parents in respect of my second marriage accordingly my parents gave consent in respect of my second marriage and the aforesaid neighbours told me to marry with Kamal Agarwal(Mittal) because very recent his wife expired due to car accident but he have two sons. Subsequently the relative of kamal Agarwal(Mittal) contacted us and shown interest to marry Kamal Agarwal (MIttal) with me, Firstly I have little objection due to recent accident because within one year of death of her previous wife no functions are to be organized like marriage, however his relatives created pressure among us and they informed me his two sons namely Kushal Agarwal and Rahul Agarwal Aged about 14 years and 16 years respectively. On 15.3.2021 our marriage was solemnized at Pranami Mandir Road, Under P.S Bhaktinagar Dist. Jalpaiguri in presence of relatives well wishers and friends of both parties without any sort of dowry however my parents organized a very wonderful wedding ceremony for two days program by giving huge number of clothes, jewellery and also spend money near about four lakhs. After marriage I came to know the sons are 20 and 17 years old in lieu of 16 and 14 respectively. And after inception of my matrimonial house I was treated like a servant, used to wake up at 6.00 A.M and whole day I used to do all house hold work but always my husband along with his two sons used to shout upon me without any rhyme or reason and my husband never loved me and respected me as a wife and both sons used to abuse me and never treated me as their mother and my husband never took any responsibility of me as a wife sometimes he physically assaulted me maximum day my husband used to go at about 6.00 P.M and return at late night with drunken condition and quarreled with me on small issues and I was confined in the house and not allowed to talk with anyone even my family members and friends and my husband also compared with me with his ex-wife. On 1.05.2021 my husband directed me to go in my parental house and bring rupees 5 lakhs from my parents to develop his business and on second may my husband with his family members along with his two sons hatched up a deep rooted conspiracy to drove from my matrimonial house as a result my husband told me to go to my parental house for two days there after I would come back to my matrimonial house. On believing the same I came to our parental house for two days but

after my departure they did not receive my calls and also blocked my contact and unblocked it also, even told my parents that they do not require this relation anymore, if I go to my husband's house then they would finish my life. My husband played with my feelings and build a physical relation as per his needs and threw me from his life like toy. I being a unfortunate wife I texted my husband in whatsapp on 27.05.2021 to save our marriage but he remained numb and again on 29.05.2021 being a unfortunate mother I sent a message through whatsapp that is the elder son but he directed me to never keep any contact with them by saying that "Listen hame pata hai ham kya kar rahe hai we don't even require a devastating problem like you and I am not anything to you neither you are anything to me so don't try to come back. This is only your life and hope fully don't dare to contact anyone of us or our family members. Nothing will be more worse than what happened. The photocopy of two whatsapp chats are annexed with this complaint.

In view of above you are requested to look into the matter and take proper legal action against them as per law.
