I, SI Pradeep Diyali of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that on today i.e 16.06.2021, at about 14:05 hrs received a specific source information that three (03) persons would be coming from Jalpaiguri side and proceed towards Bihar with a suspected consignment of Ganja in two vehicles bearing registration No. WB 70K 8970 & WB 74 AA 3896. Accordingly I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, SPC and requested him to strengthen by more police personals at Fulbari Bazar. Hence, I, diarized the fact in GDE vide NJP PS GDE No. 757 and at 14:05 hrs I, along with ASI Khagen Barman, C/1053- Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Biswajit Roy all of NJP PS left PS for Fulbari Bazar, vide NJP PS M.C.C. No. 1491/21 Date: 16/06/2021 to verify the veracity of the information vide GDE No 757 dated 16.06.2021 by Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 14.25 hrs we reached at Fulbari Bazar and parked the vehicle at considerable distance and proceeded towards Fulbari Bazar: Meanwhile, I called two disinterested witnesses namely 1) Sukamal Sen Gupta S/o Subir Sen Gupta of Saktigarh, PS- NJP, Dist.- Jalpaiguri 2) Saumya Bikash Ghosh S/o Jyoti Prakish Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any. Meanwhile, our Police party started looking for accused persons and finally saw two vehicle bearing registration no. WB 70K 8970 & WB 74 AA 3896 coming from Jalpaiguri Side and proceeding towards Siliguri Side. We stopped both the vehicles at Fulbari Bazar vehicles bearing registration no. WB 70K 8970 driven by Chandan Roy (36) and WB 74 AA 3896 driven by Swapan Roy (30) accompany by Shambhu Das (46)yrs and asked the drivers to park the car beside the I I disclosed our identity to him. On being asked they disclosed their names and address as noted ve. I told them about the information in hand but they denied. After prolong interrogation, they litted that there is Ganja in both the vehicles. Then I gave them option that whether they wanted to be ched in presence and supervision of Executive Magistrate or police Gazetted Officer. They agreed to earched in presence of police Gazetted Officer. Accordingly, I served the Notice in writing and as per vision of law to him which he duly acknowledged by receiving and signing in the copy of Notice. ordingly, I informed Sri. Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HQ), SPC rewarding the rehension of said persons with said to be Ganja and requested him through messenger to come at pari Bazar, NJP and remain present as Gazetted Officer during the time of search and seizure if any ch he duly accepted. At 15.45 hrs Sri. Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HQ), SPC ved at the spot in uniform and disclosed his identity to the detained persons as well as witnesses as a etted Officer, Sri. Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HQ), SPC I also offered the pendent witnesses and the accused persons to search me and our Police Party as per provision of law. they refused to search the police party. Under the supervision of Sri. Manabendu Sekhar Rakshit, IPS, ACP-Traffic (HQ), SPC, and in presence of independent and disinterested public witnesses I rched the detained persons physically following all formalities keeping decency but nothing could be overed on their persons except wearing apparels. Then, I, in presence of witnesses and under the pervision of Sri. Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HQ), SPC; searched both the nicle and found Six (06) packets said to be Ganja wrapped with white transparent and Brown colour stic cello tape from vehicle bearing registration No: WB 70K 8970 and Six (06) packets said to be inja wrapped with White transparent and Brown colour plastic cello tape from vehicle bearing gistration No WB74AA 3896. On demand, in presence of the Gazetted Officer Sri. Manabendu Sekhar ikshit, WBPS, ACP-Traffic (HQ), SPC, they failed to produce any valid documents in support of ssessing/procurement of said to be Ganja which were kept inside the vehicles with a intention for sale same in Bihar state.

I, accordingly, weighed the said to be Ganja by Digital weighing instrument taken by us and und total 120 (One Hundred Twenty) Kgs said to be Ganja in 12 (Twelve) separate packets and marked em as Exhibit 'A", 'B", 'C'. 'D', 'E', 'F' seized from vehicle bearing registration No. WB 70K 170 and Exhibit' 'G', 'H', 'I', 'J', 'K', 'L' seized from vehicle bearing registration No WB74AA 196. Accordingly, I seized, sealed and labeled the entire article in presence of Sri. Manabendu Sekhar akshit, WBPS, ACP-Traffic (HQ), SPC and independent witnesses and accused persons which was knowledged by the accused persons. The search, seizure and labeling was made between 16:20 hrs to 7:45 hrs. Then, I arrested the above noted accused persons after observing all guidelines of Apex court f arrest, as they violated the provisions of Narcotic Drugs by possessing said to be Ganja without any alid authority, document or license. On interrogation the accused persons as noted above, admitted that ney procured the said to be Ganja from Jalpaiguri side for the purpose of making money illegally.

Under the above circumstances, I pray to you that a specific case under proper sections of law hay kindly be started against the accused persons (i) Chandan Roy (36)yrs S/o Lt. Keshtha Roy of Iohantapara, PO- Mohitnagar, PS- Kotwali, Dist.- Jalpaiguri. (ii) Shambu Das (46) yrs S/o Lt. udhnya Das of Gedipara, PO- Bahadur, PS- Kotwali, Dist.- Jalpaiguri. (iii) Swapan Roy (30) rs S/o Naren Roy of Babupara, PO- Mohitnagar, PS- Kotwali, Dist.- Jalpaiguri and arrange for its
