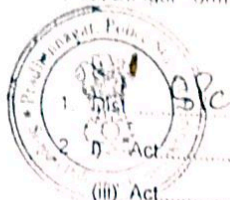

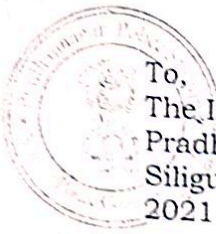

Sub: F.I.R regarding obstructing police personnel on duty and misbehaving while performing Naka Checking duty

Respected Sir,

With due respect and humble submission, I PSI Chetan Dangal of Pradhan Nagar Police station, Siliguri Police Commissionerate want to lodge a complaint against

The brief fact is that sir on 16/06/2021 at around 11:54 hrs when I along with ASI Dipak Karmakar (K-31 Night van officer) along with his two Force and C/882 Binod Tigga, L/C 1337 Anjana Basnet, L/C 1366 Nisha Subba was performing Naka checking duty at Methibari vide M.C.C No.1548 dt. 16/06/2021. The duty was going on smoothly suddenly one Maruti Suzuki swift car driving recklessly came from sukna side, I stopped the said car and ask why was he driving the car recklessly, the driver Viz: Bikash Giri (M- 45 yrs) of the said car start arguing with us, I request the driver of the car to show Driving Permit at night curfew, He did not show me any papers which justify driving at night curfew and started using abusive language to the on-duty police personnel, I request him not to create any nuisance and told to wear a mask as there is a COVID pandemic situation but, he continue creating halla on the road, later I came to know that he has consumed alcohol excessively, I send the said driver of the car with ASI Dipak Karmakar along with force of Pradhan Nagar P.S for his medical Check Up on which the on duty medical Officer stated that the said driver of the car has consumed Alcohol. Therefore, he violates the Govt. Order No. 79-CS /2020 dt. 12.04.2021 of Govt. of West Bengal and Home and Hill Affairs Department of the Govt. of West Bengal, vide notification number 237-I S.s /2M-24/2020 dated 03.06.2020 and Memo no. 486-CS /2021 dated 24 of April 2021 of Chief Secretary & Chairman, State Executive Committee WBSDMA

Hence, I pray before your good office that a specific case under proper section of Law may kindly be started against the said driver and arrange for its investigation, so that I would be able to discharge my duties without any fear.
