Subject: F.I.R For Theft Of WBSEDCL Property

Sir,

I, Suman Sengupta, S/O Ashoke Sengupta, D.E & Station Manager, Power House CCC, WBSEDCL, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complain against Suman Mahanta, S/O Prafulla Mahanta of Uttar Samar Nagar, Dabgram, West Bengal, 734008 Dist- Jalpaiguri. Yesterday at around 8.30 pm we received a complaint regarding no power at Dosti Enclave Apartment, Chayan Para when our LT maintenance van reached the spot, it was found that the 315 KVA Distribution Transformer was damaged and almost all the transformer oil has been dried out. He was identified by our workers to have been visiting the place earlier. While he himself had admitted to have stolen Electrical equipments like Copper Bus Bars, Nuts and Wires from Dosti Enclave verbally to the undersigned and other staffs of WBSEDCL, when enquired about Transformer Oil and also submitted a written statement regarding stealing at two different locations under Power House CCC. We were receiving complaints of stealing of electrical property from different apartments from the past few months under Power House CCC, While on further enquiry & investigation it was also found that earlier the residents of Green escape of Tiranga more and Bhagwati apartment of Punjabi Para had caught him red handed stealing electrical apparatus from their apartments after showing them false documents of identity, of him working for WBSEDCL on contractual basis. The loss incurred by WBSEDCL for this incident is approximately Rs 5,50,000/- (Rupees Five Lakhs Fifty Thousand Only).

This is not an isolated incident and these incidents are causing damage to the image of WBSEDCL as well as financial losses are being incurred by WBSEDCL due to stealing of property. Thus it is requested to initiate an investigation against Suman Mahanta under Section 139 (1)(a) of the Electricity Act 2003 amended on 2007 of India.
