Sir,

In producing herewith one accused person namely Rajen Sharma(31) S/O- Tek Nath Sharma of Kholachan Fapri ,PS- Bhaktinagar Dist- Jalpaiguri ,along with the following seized articles :- (1) 16 (Sixteen) bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufactured by Himalayan Endeavour PVT. Ltd, Siliguri , West Bengal and (2) 04( four) bottles of Boss country spirit containing 300 ml. each manufactured by Galaxy Bolting Plant ,Nagrakata, Jalpaiguri and (3) One Avon blue Colour bi-cycle.

I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Rajen Sharma(31) S/O- Tek Nath Sharma of Kholachan Fapri ,PS- Bhaktinagar Dist- Jalpaiguri to the that today on 18/06/2021 while I was performing Special raid duty as per order of my superior vide Bhaktinagar PS GDE NO- 1180 date 18/06/2021 received a specific input from the source at 17:55 hrs. that the above noted person was selling illicit liquor on a bi cycle at Kholachan Fapri area to his design customers for his wrongful gain. Accordingly the fact is informed to I/C Bhaktinagar PS and as per his direction I along with ASI Biplob Kumar Das, ASI Rabin Lama, CV-619 Dharmendra Roy and Cv-14 Labanamoy Barman left for Kholachan Fapri under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the above noted person and detained him with a bi-cycle. On searching found huge numbers of Himalayan Gold country made spirit containing 600 ml. each and other brand of illegal liquor which he was kept in bag in hanging position to his bi cycle illegally. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 04 months for wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 18:35 hrs to 19:05 hrs. On being asked he stated that he kept the same with a view to sale and supply at Kholachan Fapri area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Rajen Sharma(31) S/O- Tek Nath Sharma of Kholachan Fapri ,PS- Bhaktinagar Dist- Jalpaiguri as per proper section of law.
