Sarbalal Roy (iii) Sudhir Roy (29), (iv) Sanjay Sarki (22), (v) Jogan Adhikary (33), (vi) Abdul Saktar (26), (vii) Promod Mahato (30), (viii) Santanu Sarkar (30), (ix) Hari Kishor Roy (x) Tarun Barman (29) & (xi) Uttam Barman (30) under proper section of law and arrange for its investigation.
