Respected Sir,

I ASI Anupam Roy of NBMC OP (under Matigara P.S/ SPC) do hereby lodge a complaint against the truck driver of a truck bearing number plate - HR 74 B 1564 & his other associates to the effect on 11.06.2021 at about 19.45 hrs. I received a source information that one truck displaying number Plate -HR 74 B 1564 is coming from Assam side towards Bihar which is loaded with huge quantity of wooden logs. Accordingly, I informed the matter my superiors and as per kind direction myself along with force namely ASI Krishnendu Roy, C/967 Jhantu Das and CV- 158 Partha Sarkar left for at Chatthat Medical more Naka Point, Asian Highway-2, to verify the veracity of the information which ref. to NBMC & Hospital OP

Received G.D.E .No.349 dtd.11.06.2021 .Under this circumstances any search warrant or authorized On 11.06.2021 cannot be obtained without affording opportunity for the concealment of evidence or facility At 23.30 for the escape of the offender. The copy is enclosed herewith for kind perusal and information. In the mean time I called two independent witnesses namely Santosh Paswan (32 yrs./ Male) S/O Dasharath Paswan of Deshbandhupara, Railway institute , Ward No- 28, PS- Siliguri, Dist.-Darjeeling and Bishnu Roy (34 Yrs./ Male S/O Nagen Roy of Lelimpur, Halermatha, P.S-Matigara, Dist.-Darjeeling and informed them about the information in hand and requested them to remain present with us as witness during the search and seizure if necessary and in which they agreed. At 20.10 hrs. we arrived at Asian Highway -2, Near Ashiana Hotel and at 20.25 hrs. we managed to intercept the said truck bearing number HR 74 B 1564 at Asian Highway- 2, Near Ashiana Hotel under Matigara P.S/ SPC but seeing the Police team the driver flew away from the spot and found the said vehicle parked beside the Asian Highway 2 near Ashiana Hotel and found that the driver and other associates are absconding. Subsequently, we searched the vehicles and found huge numbers of stolen wooden logs loaded in the vehicle. On counting it is found that the vehicle loaded with total-59 (fifty-nine) numbers of wooden timber logs.

Accordingly, I seized the above noted truck as well as wooden logs from the spot and observing all formalities. The whole process of seizure was made in between 20.35 hrs. to 22.55 hrs.
