Sarifuddin, resident of Pachkalguri, P.O & P.S - Matigara, District - Darjeeling, would like to inform you that on 31 - 5 - 2021 at about 8 a.m all of sudden my neighbour Nebu Md @ Akbar Ali, his wife Baisakhi Khatun and his son Md. Jaidul, all are resident of Pachkalguri, P.O & P.S - Matigara, District - Darjeeling, have started pelting stone at my house and when I have raised my objection, the above named persons have started assaulting me fist and kicks and the said Baisakhi Khatun took one brick and hit on my face causing I sustain severe injuries on my nose and face and blood started oozing from the cut injuries of my face and internal injuries from my nose. The said Md. Jaidul with intention to outrage my modesty has started tearing my cloths and the said Nebu Md. @ Akbar Ali has started inducing his son to make me naked.

After the interference of local persons, I could able to survive myself and able to protect my modesty. Due to my serious injuries, I had been to Matigara B.P.H.C for my treatment and the doctors have referred me to go to N.B.M.C & Hospital for my treatment and the doctors of Medical College have prescribed for CT Scan and still I am under treatment.

After the said incident I have lodged my FIR before you on the same day i.e. 31 - 5 - 2021 and narrated the incident and subsequently on 3-6-21 I have made my complaint before the Siliguri Police Commissioner.

So requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.

The said Md. Jaidul with intention to outrage my modesty has started torning my cloths and the said Nebu Md. @ Akbar Ali has started inducing his son to make me naked.

After the interference of local persons, I could able to survive myself and able to protect my modesty. Due to my serious injuries, I had been to Matigara B.P.H.C for my treatment and the doctors have referred me to go to N.B.M.C & Hospital for my treatment and the doctors of Medical College have prescribed for CT Scan and still I am under treatment.

After the said incident I have lodged my FIR before the Office In - Charge, Matigara Police Station on the same day i.e. 31 - 5 - 2021 and narrated al the incident but the Police Officials of Matigara Police Station, instead of investigating the incident have started levelling allegation against me. Sir I am in reasonable belief that the O/C Matigara will not investigate the matter properly without your interference and still they have not registered any case against the above named persons.

So requesting you to look into the matter and direct the O/C Matigara Police Station to register the case and investigate the matter properly without any political pressure.
