Sub: Complaint in respect of illegal construction of boundary wall in E-Extension zone of Uttorayon Township at P.O & P.S- Matigara, 734010

We would like to inform your good office that on 12th May, 2021, a request was received from Chandmoni Uttorayon Welfare Society (CUWS) for erection of boundary wall in C zone & E extension zone of Uttorayon Township. On receiving the said request a joint inspection was conducted of the relevant areas.

Subsequent to the inspection, for the benefit and safety of the residents we allowed CUWS to erect the boundary wall in C zone alongside the existing wire fencing. However, with regard to the boundary wall in the E extension zone it was categorically stated that the land adjacent to the E extension zone is not part of the Uttorayon Township. It was further mentioned that no construction of any boundary wall or otherwise should be carried out on any portion of the land which was not within the Uttorayon Township boundary. It was very clearly stated that any boundary wall construction in the E extension zone shall have to be only in the township boundary as per the applicable Master Plan approved by the authorities in the year 2008. In the joint inspection, it was assured by the representative of CUWS that they would carry out the construction of wall only in the C zone and any construction in the E extension zone will be considered and discussed later.

Despite of above, we were shocked to discover that CUWS unilaterally, without any information to the company or undersigned, started to erect the boundary wall in the E extension zone. By our letter dated June 15, 2021 we have called upon CUWS to stop all the construction in the said E Extension zone. Despite of our request CUWS in defiance and wrongfully so, are forcefully continuing the construction activities.

It may also be informed that the Hon'ble State Disputes Redressal Commission. Siliguri Circuit Bench in CC 22 of 2019 passed an order dated June 4, 2019, as extended from time to time, and directed to maintain status quo and restrain from changing the nature and character of the land in the West and East side of the Central Park, and all the green areas used and enjoyed by the residents of the said Uttorayon Township.
