Sir,  
In producing herewith arrested accused person named Paritosh Paul (31), S/O-Late Bancharam Paul, of-Vill- Rangapani, Paul Para, PO-Rangapani, PS-Bagdogra, Dist -Darjeeling along with copy of memo of arrest and seized articles viz (i) 20 (twenty) bottles kingfisher strong premium Beer each containing 650ml MRP Rs. 130/-each totaling amount of Rs 2600/- with proper police escort.

Received on 18/6/2021 at 22.15 hrs vide GDE No 891 dt 18/6/2021 and started Matigara PS Case No 526/21 dt 18/6/2021 u/s 46 A(c) B.E. det and endorsed to ASI Anupam Roy of NBMC for its investigation

Today i.e 18.06.2021 at 18.40 hrs I, ASI Prembhakta Mallick of NBMC OP along with C/131 Kanuram Sarkar, CV/650 Raju Sarkar and CV/ 920 Kamal Barman while conducting special raid against anti social elements, warrantees, ID liquor etc in vehicle no WB74/8035 at different area under NBMC OP in course of which I received an information from source that one person is selling Liquor illegally in huge quantity in a clandestine way in petty shop at Kawakhari near Laska Bridge. As soon as after receiving information I informed the matter to O/C NBMC OP and as per his order and instruction I along with force conducted raid in petty shop of Paritosh Paul at Kawakhari. During raid I found one Paritosh Paul (31), S/O-Late Bancharam Paul, of-Vill- Rangapani, Paul Para, PO-Rangapani, PS-Bagdogra, Dist-Darjeeling is hidden illegal liquor inside his shop and selling it to the customers in concealed manner. On demanded he failed to produce any valid papers and license of those articles. Hence I seized those illicit liquors U/S 102 CrPC after preparing proper seizure list duly signed by the witnesses as well as the accused and also labeled the same. On interrogation he disclosed his name as mentioned above and admitted that he procured the liquor illegally and had been selling the same illegally to the people then I arrested him u/s-41 CrPC. The search, seizure, label and arrest were made from 19.10 hrs to 19.35 hrs. Then we left the place with the arrested person and the seized articles

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Paritosh Paul (31), S/O-Late Bancharam Paul, of-Vill- Rangapani, Paul Para, PO-Rangapani, PS-Bagdogra, Dist-Darjeeling and kindly arranged for its investigation.
