In producing herewith three (03) persons namely 1] Prakash Ekka(21), S/O- Joseph Ekka 2] Amin Orawn(22) S/O Bishnu Orawn and 3] Sankar Kumar Mahali(28) S/O kaharu Mahali all of Matigara Tea Estate, PS- Matigara, Dist- Darjeeling along with seized articles viz., 1] 35 (thirty five) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 21 liters, value Rs 3500/-), and marked as 'exhibit-A' 2] one bottle Himalayan Gold 60 UP Country Spirit taken out from exhibit -A as sample for examination and marked as "exhibit A-1" and 3] One plastic Jar Containing 10(ten)liters illicitly distilled liquor and marked as 'exhibit-B' and 4] one bottle, containing 600 ml, illicitly distilled liquor taken out from 'exhibit-B' as sample for examination and marked as "exhibit B-1" I PSI Shekhar Adhikary presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted persons that today (18.06.2021) at 21.15 hrs while performing Special raid duty, myself along with ASI Nitai Mandal, C/986 Rajib Sarkar C/1008 Kanak Roy, had been to Dewnia More area and found that the above noted persons were standing there with two bags loaded with above noted seized articles. Then I detained the persons with the help of my accompanied force, on being asked they disclosed their identity as noted above and stated that they brought the liquors to sell in this area. On being search of this bags in presence of available witnesses the above noted seized article were found inside their bags. On being asked they failed to produce any valid license/papers for selling of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned persons. While on the time of detaining, the persons who were taking liquor managed to flee from the spot. On further interrogation of the arrested persons it could be learnt that they are involved in selling and possessing the liquor without any valid license for their illegal gain. The seizure has been made in between 22.05 hrs to 22.35 hrs.

Therefore I pray before your good self that a specific case against the above noted accused persons namely 1] Prakash Ekka(21), S/O- Joseph Ekka 2] Amin Orawn(22) S/O Bishnu Orawn and 3] Sankar Kumar Mahali(28) S/O kaharu Mahali all of Matigara Tea Estate, PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
