Sir,

In producing here with eight arrested accused persons namely namely 1)Md. Sadam (27) S/O Md. Sabir of Champasari, PS-Pradhannagar, Dist-Darjeeling, 2) Upender Roy (35) S/O Bhutan Roy of Mala Hotel & Pann Ghar, Near Circuit House, Chapmasari, PS-Pradhannagar, Dist-Darjeeling, 3) Bankim Sarkar (26) S/O Poritosh Sarkar of Matigara, Patiram Jote, PS-Matigara, Dist-Darjeeling, 4) Ashok Kumar Roy S/O Lt. Devan Roy of Rajendra Nagar, PS-Pradhannagar Dist-darjeeling, 5) Balaram Das (22) S/O Lt. Komani Das of South Ektiasal, PS-Bhaktinagar, Dist-Jalpaiguri, 6) Subham Chakroborty (27) S/O Sadhan Chakroborty of East Dhantala, PS-Bhaktinagar, Dist-Jalpaiguri, 7) Rahul Amin(45) S/O- Lt. SK Sharhem Ali of Malda Samse, PS- Ratua, Dist- Malda, 8) Firoj Alam (28) S/O Mustak Hussain of Malda, Samse PS- Ratua, Dist- Malda arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 18.06.2021 while performing special van duty I had been to Champsari More along with ASI Kalipada Barman, ASI Raju Sarkar , ASI Ratan Pradhan , ASI Debasish Das and and found that the above noted persons were gathering and loitering without wearing mask. As they violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3<sup>rd</sup> June, 2020 and Memo No 486-CS/2021 dated 24<sup>th</sup> April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I, finding no other alternative, along with above mentioned officers apprehended them and I arrest them U/S 41C.rPC. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
