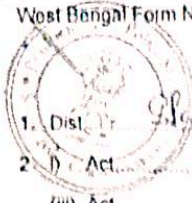

Sir,

In producing herewith one arrested person namely Mithu Sah (29) S/O Lt. Narayan Sah of B.R.I Colony, PS-Pradhannagar, Dist-Darjeeling along with following articles under proper seizure list i.e i) 30 bottle Himalayan gold 60UP country spirit each bottle containing 600ml, ii) 24 bottle Himalayan gold 60UP country spirit each bottle containing 300ml.

I, ASI Debasish Das of Pradhannagar PS, SPC would like to lodge a written complainant against the above noted accused person to the effect that on 18.06.2021 at 20:52 hrs received a source information that one person namely Mithu Sah (29) S/O Lt. Narayan Sah of B.R.I colony, Ward No. 01, PS-Pradhannagar, Dist-Darjeeling stored huge quantity of illicit liquor in his shop at Gate Bazar under Pradhannagar PS and was selling the same illegally for his illegal gain. Accordingly, I shared the information with you and as per your kind direction diarized mater vide Pradhannagar PS GDE No.991 Dated-18.06.2021. Myself along with ASI Asit Kr Singha, CV/ 646 Baban Das & CV/645 Pankaj Gupta all are of Pradhannagar PS, SPC left PS for Gate Bazar to verify the veracity of the information. On reaching at Gate Bazar the source identified the shop and the person. I tried to call local witnesses for search and seizure, but due to lockdown issue nobody was present there. Accordingly, I cordoned the area and apprehended the above noted person and conducted raid and recovered above noted articles from inside his shop. On demand he failed to produce any valid document in favor of recovered articles. On interrogation he admitted that he had been selling the same illegally since long for his illegal gain. Accordingly, I seized the above noted articles under proper seizure list & labeled the same and arrested him U/S 41 Cr.P.C and issued memo of arrest. The seizure was made between 22:15 hrs to 22:35 hrs.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Mithu Sah (29) S/O Lt. Narayan Sah of B.R.I Colony, ward No.01, PS-Pradhannagar, Dist-Darjeeling and arrange for its investigation.
