Narayan Sah of B.R.I colony, Ward No. 01, PS-Pradhannagar, Dist-Darjeeling stored huge quantity of illicit liquor in his shop at Gate Bazar under Pradhannagar PS and was selling the same illegally for his llegal gain. Accordingly, I shared the information with you and as per your kind direction diarized mater vide Pradhannagar PS GDE No.991 Dated-18.06.2021. Myself along with ASI Asit Kr Singha, CV/ 646 Baban Das & CV/645 Pankaj Gupta all are of Pradhannagar PS, SPC left PS for Gate Bazar to verify the veracity of the information. On reaching at Gate Bazar the source identified the shop and the person! I tried to call local witnesses for search and seizure, but due to lockdown issue nobody was present there. On demand he failed to produce any valid document in favor of recovered articles. On interrogation he admitted that he had been selling the same illegally since long for his illegal gain. The seizure was made between 22:15 hrs to 22:35 hrs.
