Sir,

I, Lila Tamang, Wife of Ajit Tamang, resident of Airport More, Gwalabusti, P.S.- Bagdogra, District- Darjeeling, and presently residing at M.M. Tarai, Bengdubi Road, P.S.- Bagdogra, District- Darjeeling, would like to inform you that in the year 1989 I was married to Ajit Tamang, Son of Late Bir Bahadur Tamang, presently posted at Sadar Bazar Delhi Cant, BN- EME, 1087 DSC Platoon, as NK, Army No. 10373879L, having phone no. 891824003. That after marriage my husband took me in my matrimonial house at Pokharjabong, Sukhia Pokhri, Darjeeling. That we started living there as husband and wife. That immediately after marriage I noticed that my husband is hot tempered and very dominating in nature. That he used to shout at me on petty issues and even assaulted me with kicks and blows. I used to remain scared from him and never had the courage to protest. That he was very negligent towards me and my children and never provided sufficient maintenance for me and my children and due to which I was compelled to work as a worker in tea garden at Darjeeling. That during his holidays, my husband used to come at Darjeeling and most of the time he used to remain in drunken condition and had illicit affair with several women and when I used to say him anything regarding this, he used to physically torture me. Because of such tortures, I went into depression.

That subsequently my husband sold the property of Darjeeling and shifted me along with my children to Airport More, Gwalabusti, P.S.- Bagdogra, District- Darjeeling. That with the paltry sum of maintenance it was not possible for me to run the house and so whenever I asked for any maintenance, my husband used to beat me with his army boots on my head in front of my children. On and off my husband used to physically assault me with kicks and blows in front of my son and he used to threaten me to give divorce as he wanted to marry someone else. That recently, on 15/6/2021 I came to know from my son and daughter-in-law that he had married another woman named Roma and has also posted his marriage photo with the said woman in his facebook account. That they showed me the photographs from there. That I also found that my husband has made a fabricated dependent card by removing my photo from my current dependent card and had pasted the photo of that lady and my husband has posted the said dependent card in his facebook account wherein my name is there in the dependent card but the photo of the said lady is affixed. That my husband has inflicted immense mental and physical torture upon me and neglected me and I

therefore request you to look into the matter take necessary action against my husband.
