Sir,

In producing herewith three (03) arrested accused persons namely; 1) MD Ajit 28yrs s/o Md Hanif of Tambari PO: Liusipokri PS, Phansidewa Dist, Darjeeling 2) Subhankar Ghosh (26), S/O Dulal Ghosh of Ghosh Para, Rangapani, PS, Phansidewa, Dist, Darjeeling 3) Md Hassen 32yrs s/o Md Meghu of Tiger Busty Suryanagar PS, Bagdogra Dist, Darjeeling with the following seized articles under proper seizure as per seizure list;

- a). One plastic zipper packet containing, 290 grams NDPS substance believed to be Brown sugar Marked as - as "Exhibit A" and out of which 20 grams are taken randomly as Sample for examination at CFSL, and marked as "Exhibit A-1"
- b) One Two wheeler Motor Cycle styled as Apache white color bearing Reg. no WB74AK/8771.
- c) One smart Mobile phone oppo Model - CPH2239 having IMEI No 860672058742797 and SIM vide connection no 6295194542 recovered from the possession of accd, Md Ajit.
- d) Four numbers of Mobile phone all of without SIM, Vivo, Tecno Spark, SAMSUNG Duos, one black color without styled.
- e) Three pcs small size weighing machine.
- f) Indian currency denomination of i) Rs, 2000x2 pcs = Rs, 4000/= ii) Rs, 500x179 pcs = Rs, 89.500/= iii) Rs, 100x725 pcs = Rs, 72.500/= iv) 200x145 pcs = Rs, 29.000/= v) Rs, 50x400 pcs = Rs, 20.000/= Total cash Rs, 2.15.000/= (Two lacs fifteen thousand).
- g) One yellow colour plastic carry bag having "THANK YOU" printed on it (in English).

I, SI Sudip Kr Saha of Bagdogra P.S. S.P.C do hereby lodged this written complaint against the above noted three arrested persons (Add, not verified) to the effect that today on 18.06.2021 at about 15.35 hrs. I received a specific reliable source information that a gang congesting three persons is coming towards Rangapani area from Matigara side by a two wheeler Motor Cycle styled as Apache white color bearing Reg. no WB74AK/8771 they carrying huge quantity of Brown Sugar for delivering the same to their designed customers at in and around Tambari, Liusipokri area under Phansidewa PS, and they would reach shortly with their destination. Further, source stated that he was at Rangapani near Rail gate and he would identify and show the accused. I requested him to be there at that place and assist Police, to which he agreed. I accordingly shared the information with the Officer in Charge, Bagdogra PS, and SPC in writing. I diarized the fact vide Bagdogra PS GDE No. 913 dated 18.06.2021 and subsequently, as per direction of O.C. PS, I along with ASI Dharendra Nath Mondal, ASI Jakirul Islam, Const- 410 Mantosh Singh, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/389 Janak Singha all of Bagdogra PS, SPC along with investigation kit, gala seal, candle, match box, weighing machine (Certified by Weight and metallurgy Department), etc. left for Rangapani Rail

gate area under Bagdogra PS, by govt. Vehicle (hired) to verify the veracity of the information vide Bagdogra PS GDE no. 914 dated 18.06.2021 and MCC No. 2021 dated 18.06.2021 at 15.45 hrs. under this circumstance any search warrant or authorization cannot be obtained for not affording opportunity for the concealment of evidence or facility for the escape of the offender.

At around 16.15 hrs, I along with accompanying officer and force reached at near Rangapani area parked the vehicle at considerable distance, and proceeded towards Rangapani Rail gate area on foot we reached near Rangapani Rail gate and contacted source, who stated that he would assist us and present at that place. Meanwhile, I approached to two persons on that locality namely i) Sri Pranay Sarkar 33 yrs s/o Bankim Ch Sarkar of Rangapani bazar PS Bagdogra, Dist. Darjeeling ii) Sri Suk Deb Biswas 40 yrs s/o Late Santi Biswas of Rangapani PS Bagdogra, Dist. Darjeeling and shared the information in hand with them and requested them to act as witness, if any search and seizure. They both agreed to remain with us. I along with officers, force, witnesses and source started keeping watch on the two wheeler motor cycle coming from Ranidanga SSB side at Rangapani Rail gate.

In course of special Checking at near Rangapani Rail gate area around 16.35 hrs, one Two Wheeler Motor Cycle styled as Apache white color bearing Reg, no WB74AK/8771 was found to be coming towards Matigara side and detain near Rangapani Rail gate. Being identified by the source, we signalled the said Motor Cycle to stop but seeing the police party, they tried to flee away from the spot but somehow, we managed to apprehend them seeing their activities there is strong reason to believe that they were possess something illegal in their possession and motor cycle. Accordingly, we disclosed our name and identity to them as Police officers from Bagdogra PS. On interrogation they disclosed their name and identities as noted above. Then I share them the information in written regarding consignment of NDPS substance believed to be Brown Sugar kept concealed with their possession and motor cycle. I asked them whether they wanted to be searched in presence of Executive Magistrate or Gazetted Officer or not, then they agreed to be searched in presence of any of them. I also served Notice u/s 50 of NDPS Act to them in accordance with the Provision of Law individually in this regard which they duly acknowledge in written to search their body and Motorcycle.

Then I, informed the matter to O/C Bagdogra PS and as per his kind order at 16.45 hrs, I sent a letter through C/410 Mantosh Singh, in the same vehicle on which we had come for raid to Shri Narendra Kalikote, Asstt. Commissioner of Police (SB), SPC who had been detailed to act as Special Executive Magistrate of SPC for the day, informing him regarding the interception of the accused persons and suspected to be possessing huge quantity of believed to be Brown Sugar and with a request him to come at Rangapani near Rail gate and remain present to supervise the search and seizure,


At 18.15 hrs, Shri Narendra Kalikote, Asstt. Commissioner of Police (SB), SPC, who had been detailed to act as Special Executive Magistrate of SPC for the day arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent witnesses and under his supervision, I offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Then I search the above noted apprehended persons observing all formalities keeping their decency and while searching their possession recovered one smart Mobile phone oppo Model - CPH2239 having IMEI No 860672058742797 with one SIM vide connection no 6295194542 recovered from the possession of Md Ajit out of three apprehended persons and as per their leading statement on search the motor cycle Registration No.WB74AK/8771 down side on seat recovered one yellow colour plastic carry bag having "THANK YOU" printed on it (in English) in which one Plastic zipper packet containing huge quantity of brownish powder on weighing total 290 grams, three small weighing machine, four nos of Mobile phone without SIM and Indian currency cash Rs, 2.15.000/= in different denomination as noted above inside the yellow plastic carry bag. On demand the all three detained persons failed to produce any valid document in support of possessing of the suspected NDPS substance believe to be brown sugar accordingly, I seized all the above noted mentioned articles under proper seizure procedure and sealed, labeled the same as follows a) One plastic zipper packet on weighing containing, 290 grams NDPS substance believed to be Brown sugar Marked as - "Exhibit -A" and out of which 20 grams are taken randomly as Sample for examination and marked as "Exhibit A-1" b) One Two wheeler Motor Cycle styled as Apache white color bearing Reg, no WB74AK/8771. c) One smart Mobile phone oppo Model-CPH2239 having IMEI No 860672058742797 and one SIM vide connection no 6295194542 recovered from the possession of accd, Md Ajit. d) Four numbers of Mobile phone all of without SIM, Vivo, Tecno Spark, SAMSUNG Duos, one black color without styled e) Three small weighing machine f) Indian currency denomination of i) Rs, 2000x2 pcs = Rs, 4000/= ii) Rs, 500x179 pcs = Rs, 89.500/= iii) Rs, 100x725 pcs = Rs, 72.500/= iv) 200x145 pcs = Rs, 29.000/= v) Rs, 50x400 pcs = Rs, 20.000/= Total cash Rs, 2.15.000/= (Two lacs fifteen thousand). g) One yellow colour plastic carry bag having "THANK YOU" printed on it (in English) duly signed by the independent witnesses and acknowledge by the accused persons in presence of Special Executive Magistrate of SPC. The whole search seizure labeled procedure was made in between 18.20 hrs to 19.25 hrs

On further interrogation, the above noted arrested accused persons admitted that they had been procuring the brown sugar clandestinely from Matigara area for the purpose of selling the same in high rate to their designed customers at Tambari, Liusipokri under Phansidewa PS, area for their wrongful gain during pandemic COVID time by illegal means. On examine out of three Md Ajit admitted that he had been arrested once again by this PS, in the year January 2020 vide Bagdogra PS, case no 03/2020 dtd, 05.01.2020 U/S 21/22 NDPS Act and was in Jail for long time.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely 1) MD Ajit 28yrs 2) Subhankar Ghosh (26), 3) Md Hassen 32yrs has been involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. I arrest them also informing them their ground of arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely) MD Ajit 28yrs s/o Md Hanif of Tambari PO: Liusipokri PS, Phansidewa Dist, Darjeeling 2) Subhankar Ghosh (26), S/O Dulal Ghosh of Ghosh Para, Rangapani, PS. Phansidewa, Dist, Darjeeling 3) Md Hassen 32yrs s/o Md Meghu of Tiger Busty Suryanagar PS, Bagdogra Dist, Darjeeling and arrange for its investigation.


