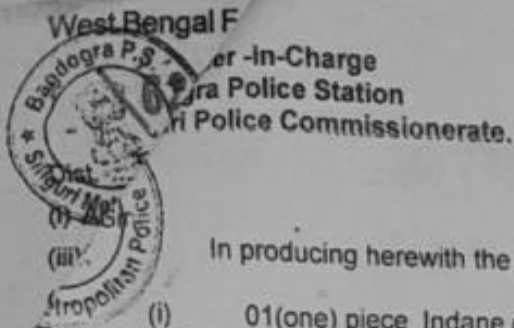

Sir,

In producing herewith above seized under proper seizure list. I SI Pradip Chakraborty of Enforcement Branch Siliguri Police Commissionerate do hereby lodge this written complaint against the sweet shop owner namely Kanak Ranjan Howlader (33) S/o Krishna Howlader of Bhujipani Bazar, Loknath nagar, Bagdogra, PS- Bagdogra Dist- Darjeeling shop styled as "Shri Krishna Sweets" at Bhujipani Bazar, Lokenath nagar, Bagdogra, Dist: Darjeeling who was illegally procured domestic LPG cylinder and using the domestic Gas cylinder at his Sweet Shop styled as "Shri Krishna Sweets" situated at Bhujipani Bazar, Lokenath nagar, Bagdogra, Dist: Darjeeling for commercial purpose without any valid documents or license, to the effect that today i.e. 19.06.21 at 12.25 hrs I received an information from reliable source that one Kanak Ranjan Howlader (33) S/o Krishna Howlader of Bhujipani Bazar, Lokenath nagar, Bagdogra, PS- Bagdogra Dist- Darjeeling styled as "Shri Krishna Sweets" , at Bhujipani Bazar, Lokenath nagar, Bagdogra, Dist: Darjeeling has been using the domestic Gas cylinder at his Sweet Shop for use commercial purpose for his wrongful gain.

As per direction of my superiors and ACP Enforcement Branch, SPC I, along with SI Goutam Kundu, ASI Prasanta Bardhan, ASI Ashok Biswas, C/424 Manik Roy of EB SPC left for Bagdogra PS vide EB SPC M.C.C No 74/21 dt.19.06.2021 with investigation kit. The matters informed to Bagdogra PS vide Bagdogra PS GDE No. 960 /21 Dated 19/06/2021 at 13:15 hrs. with officer and force of Bagdogra PS had been to Bhujipani Bazar, Lokenath nagar, PS- Bagdogra, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure if required and at about 14'35 hrs on reaching at Bhujipani Bazar, Lokenath nagar, PS- Bagdogra, Dist- Darjeeling we contacted with source and being shown and identify by the source I along with officers and force entered into Sweet Shop styled as "Shri Krishna Sweets" of Kanak Ranjan Howlader (33) S/o Krishna Howlader of Bhujipani Bazar, Loknathnagar, Bagdogra, PS- Bagdogra Dist- Darjeeling I found that the accused Kanak Ranjan Howlader was preparing sweets at his sweet shop by using the LPG domestic Gas cylinder for preparing sweet at his Sweet Shop without any valid documents for commercial use on demand he could not produce any valid documents in support of using the LPG cylinders for commercial use. Further local enquiry it is revealed that the above noted accused person was using the domestic LPG cylinder for preparing food at his Sweet Shop as a commercial use for his wrongful gain without any valid document. **On seeing the Police party the shop owner namely Kanak Ranjan Howlader fled away from the shop to avoid police arrest.**

The owner of the shop Kanak Ranjan Howlader used the domestic LPG cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles after preparing proper seizure list and label. The seizure was made in between 14.45 hrs to 15.05 hrs)

Hence, I pray before you a specific case may kindly be started under proper section of law against accused person Kanak Ranjan Howlader (33) S/o Krishna Howlader of Bhujipani Bazar, Loknath nagar, Bagdogra, PS- Bagdogra Dist- Darjeeling and arrange for its investigation.
