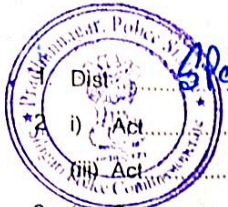

Subject: FIR of house burglary

Respected Sir/Madam,

I, Bibha Rai is writing this to inform
you about a daring, day-light robbery that has taken place at my
house.

I am widow of Mr Prem Bahadur Rai, who was a staff of
DIB Siliguri. My house is situated at Shib Nagar, Ujanu (East), Ward
no 46 of SMC, P.O + P.S - Pradhan Nagar, Siliguri-734003 and it is
very close to the Dog Squad of Siliguri Police Commissionerate:

I live with my younger daughter only. Today both of us
went for doctor consultation at around 11 am and we returned
home at around 04:15 pm. We were shocked to find that the
gates of our house was broken. The almirahs, lockers inside our
house ~~was~~ were also in broken condition.

As per initial estimate, the thieves have taken 15
(fifteen) vori golden ornaments, 23000 (twenty three thousand)
rupees in cash, one ATM of State Bank of India, several coins
and small utensils made of silver, with them, along with all bills.

I am completely devastated and shocked by this audacious
robbery. My husband himself was a police personnel and I never
thought that an incident like this can happen to us.

I urge your kind office to immediately swing into action
and nab the culprits. I would be extremely obliged to you if
you could recover the stolen items.
