1, ASI Ashit Kr. Singh of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint and producing one accused person namely Mithu Munda (49) S/O Late Kaliya Munda of Dhakni kata, Khaldhari Lines P.S Prodhan NagarDist: Darjeeling along with i) 21 (Twenty one) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, ii) 12 (Twelve) bottles of Troubo Strong premium Beer 650 ml each which has been seized under proper seizure list to the effect that on 19.06.21 at 18.15 hrs I received a secret source information that a person of Dhaktni kata, Khaldhari lines has stored huge quantity illegal liquor and selling the same there Accordingly ,1 informed the matter to the I/C Pradhan nagar PS, SPC and as per his kind direction myself along with ASI Debasihs Das, , CV 131 Ranjan Sharma, CV 128 Ajay Kumar sahani, CV 223 Sapan Cheetri all are of Pradhan nagar P.S. left for Mallaguri to verify the veracity of the source information vide Pradhan nagar P.S. GDE No 1042 dated 19.06.21 at 18.15 hrs . On reaching at the spot at 18.45 hrs and after being confirmed by the sources, I apprehended one person namely Mithu Munda (49) S/O Late Kaliya Munda of Dhakni kata, Khaldhari Lines P.S Prodhan Nagar Dist: -Darjeeling. On interrogation it could be learnt he has been running his illegal business for his illegal gain since long. He has been selling illegal liquors to public without any document or valid license for his illegal gain since long. Accordingly, search has been conducted inside the room and recovered (i) 21 (Twenty one) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, (ii) 12 (Twelve) bottles of Troubo Strong premium Beer 650 ml each. On demand said Mithu Munda failed to produce any document in respect of recovered liquors. It is a violation of Bengal Excise Act, I accordingly seized the said liquors from the apprehended person under proper seizure List duly signed by him and the witnesses. This seizure was made in between 19.25 hrs and 19.55 hrs, Accordingly, I arrested the accused person Mithu Munda (49) S/O Late Kaliya Munda of Dhakni kata, Khaldhari Lines P.S Prodhan NagarDist: - Darjeeling after preparing memo of arrest and intimating the ground of arrest. At 20.10 hrs the arrested accused person along with seized articles has been brought to Pradhan nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Mithu Munda (49) S/O Late Kaliya Munda of Dhakni kata, Khaldhari Lines P.S Prodhan NagarDist: Darjeeling and arrange for it's investigation.
