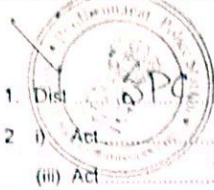

In this regard I beg to complain that on 20.06.2021 while performing K29-II van duty myself along with force had been to Champsari More and found that the above noted persons were gathering and loitering without wearing mask. As they violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I, finding no other alternative, along with above mentioned officers apprehended them and I arrest them U/S 41C.rPC. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
