Sir,

With due respect and in producing herewith the arrested accused person namely Bhola Das S/o Jogen Das of Thakur Nagar Railgate, PS- NJP, Dist.- Jalpaiguri and following seized articles viz:

- 1) 49 (Forty nine) bottles Of Himalayan Gold Premium 60 up Country Spirit each containing 600 ml in each pack; MRP Rs. 100/- each (Total value Rs.4,900/-).
- 2) 02 (Two) bottles of TUBORG Premium Beer each bottle containing 650 ml in each bottle, Marked @ Rs- 119. (Total Value Rs. 238/-)
- 3) 01 (One) Officer Choice Deluxe Whiskey containing 750 ML in a bottle, marked @ Rs- 580. (Total Value- Rs.580/-)

I, SI Shib Sankar Das of NJP PS, Siliguri Police Commissionerate, do hereby lodge this complaint to the effect that on 18/06/2021 at about 19.55 hrs during special simultaneous drive, received a secret source information that one Bhola Das S/o Jogen Das of Thakur Nagar Railgate, PS- NJP, Dist.- Jalpaiguri is selling/stored huge quantity of ID liquor at his residence at Surya Sen Colony for his wrongful gain. Accordingly the matter was diarised vide NJP PS GDE No: 872, date:18.06.2021 and informed the fact to O/C, NJP PS, SPC and per his direction Myself along with force C/1089 Bablu Das, C/1441 Shakti Padda Das, C/1438 Kamal Barman left for Thakur Nagar Railgate to work-out the information. At about 20.15 hrs being shown by the source myself along with the force had been to the house of Bhola Das S/o Jogen Das of Thakur Nagar Railgate, PS- NJP, Dist.- Jalpaiguri and found that he is selling the illicit liquor illegally in shop and the Police team detained him. On interrogation he disclosed his identity as noted above and also searching the hotel and found 49 (Forty nine) bottles Of Himalayan Gold Premium 60 up Country Spirit, 02 (Two) bottles of TUBORG Premium Beer and 01 (One) Officer Choice Deluxe Whiskey inside of his shop. On demand he failed to produce any valid documents in respect of the seized articles. Accordingly, I seized all the above noted articles in between 20.20 hrs to 20.50 in presence of witnesses and also arrested the accused Bhola Das S/o Jogen Das of Thakur Nagar Railgate, PS- NJP, Dist.- Jalpaiguri u/s 41 Cr.P.C after maintaining all the formalities.

Hence, it is evident that the accused person named Bhola Das S/o Jogen Das of Thakur Nagar Railgate, PS- NJP, Dist.- Jalpaiguri is involved in selling of illicit liquor illegally without any valid license for their wrongful gain.

Therefore, I request that a specific case may kindly be started against the accused person namely Bhola Das S/o Jogen Das of Thakur Nagar Railgate, PS- NJP, Dist.- Jalpaiguri under proper section of Law and arrange for its investigation.
