
Respected Sir,

I Sri Prasenjit Mazumder, S/O Sri Subrata Majumder, resident of Ashmi Tower, Nazrul Sarani, Hakim Para, P.O & P.S- Siliguri, Dsit-Darjeeling, beg to inform you that I being the chairman and Managing Director of a company under the name and style M/S Annex Infrastructure India Ltd. preferred a Misc Appeal being No. 22/2021 along with an application under Order 39 Rule 1 and 2 before the Ld. District and Sessions Judge at Jalpaiguri, against 5 (five) persons namely Kalipada Das, Manju Devi, Bikash Dutta, Mubarak Ali and Uttam Sen( herein after called the said person) on 05/06/2021.
