Devdhanu Gupta and my friend namely Santosh Sharma (26) S/O Sri Jagdishwar Sharma, protested, they suddenly attacked me and my said friend Santosh Sharma, with iron nuckle punch and we both received severe head injury and immediately rushed to Siliguri Distt.
