Sir,

In producing herewith arrested accused person namely Pramila Paswan Biswas (40) W/O Anil Paswan of Railway Quarter, Tikiapara near Flyover, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 75 ( Seventy five ) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 75 x Rs 100/- =RS.7,500/-) as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Pramila Paswan Biswas (40) W/O Anil Paswan of Railway Quarter, Tikiapara near Fly over, Ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 18.06.21 at 15.05 hrs I received a source information that the above noted person was busy to sale ld liquor illegally at her house situated at Tikiapara near Flyover ward no.28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1109 dated 18.06.21 and informed the fact to I/C Siliguri PS. As per his direction of I/C Siliguri PS, I along with ASI Siben Sarkar, LC/1210 Nilam Chhetri, LC/1272 Prakriti Gholay, LCV/176 Parbati Barman, CV/283 Prosenjit Dey and CV/622 Ramanath Barman and left Tikiapara near Flyover ward no.28 Siliguri PS vide Siliguri P.S GDE NO: 1110 dated 18.06.21 to verify the veracity of the information. On reaching at 15.25 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, the above noted person disclosed her identity as noted above. On searching we found i) 75 ( Seventy five ) sealed bottles of

West Bengal @ Rs 100 each (Amounting of 75 x Rs 100/- =RS.7,500/-) which was kept concealed in her house. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since last eight (08) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.45 hrs to 16.50 hrs. On being asked he stated that she used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Pramila Paswan Biswas (40) W/O Anil Paswan of Railway Quarter, Tikiapara near Flyover, Ward No. 28, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigate.
