Sir,

In producing here with the accused person namely-1) Smt. Punam Thapa (43) yrs, W/O-Sri, Gopal Thapa of Mahananda Para, Near Mahananda club, ward No-4, P.S-Siliguri, Dist. Darjeeling, along with seized (i) 10 (Ten) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 1000/- (one thousand) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1" ii) 03 (Three) bottles of KINGFISHER Strong Premium Beer 650 ML, in each bottle mentioning MRP of Rs-130/- in each bottle i.e. total amount of Rs-390/- (Three hundred Nanty) in which one bottle taken as Sample and marked as Exhibits- "B"-1.

The fact of the case is that today (18- 06--21) myself along with force and lady constables while performing special raid against illegal alcohol, at 14.25 hrs, I received a source information that the above noted Lady persons namely1) Smt. Punam Thapa (43) yrs, W/O-Sri, Gopal Thapa of Mahananda Para, Near Mahananda club, ward No-4, P.S-Siliguri, Dist. Darjeeling Siliguri, Under Khalpara TOP without any valid license and documents in higher price than the actual value for their illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for at Mahananda Para, Siliguri, in the house of accused person, P.S- Siliguri, Dist. Darjeeling to verify the veracity of the information vide Khalpara TOP GDE No-620/21 Dated- 18-06- 21. After reaching at Mahananda Para, Siliguri, Darjeeling at 14.30 hrs and as shown by the source, I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to flee away but we managed to intercept them . On being asked the above noted person disclosed her identity as mentioned above. During search, I could recover the above noted alcohol kept in the house of the accd. Person a gunny bag. During interrogation she admitted that she is selling alcohol for her wrongful gain. On demand she failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since long. Accordingly, I seized the above noted recovered LD. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 14.35 hrs to 15.15 hrs On 18-06-21.

Under the circumstances one specific case may kindly be started against the arrested accused person namely1) Smt. Punam Thapa (43) yrs, W/O-Sri, Gopal Thapa of Mahananda Para, Near Mahananda club, ward No-4, P.S-Siliguri, Dist. Darjeeling, for the possessing and selling alcohol illegally and arrange for its investigation of the case.
