Sir,

In producing herewith one lady namely Parboti Dubey-37yrs w/o Lt Raj Kumar Dubey of Santoshinagar, Near Santoshi Mandir, ward No-V, PS Siliguri Dist Darjeeling along with the following seized articles as per proper seizure list:

1. 15 (Fifteen) pet bottles of Himalayan Gold 60 up country spirit (each Bottle containing 600ML & in each bottle mentioning M.R.P of Rs- 100/-in each bottle i.e. total amount of Rs- 1500/- (One thousand Five hundred only)) which was kept in one gunny bag.

I, SI Srimanta Chatterjee of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodged a written complainant against the above noted lady to the effect that on 19.06.21 at 08.10 hrs received an information from Santoshinagar under Siliguri PS that one lady has gathered huge quantity of illegal liquor in her house for selling the same in the open market for her wrongful gain. (This refers to Khalpara TOP GDE No-649 dated 19.06.21) Inform the matter over telephone to you. As per your kind instruction myself along with SI Upendra Nath Roy, ASI Aminul Islam with force and lady police personals left for Santoshinagar. After reaching at Santoshinagar held raid in the house of above noted lady in presence of witnesses and recovered the above noted articles from the possession of above referred lady. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in open market for her wrongful gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizure list and level and took signature of the accused person one bottle taken as sample. (The seizure was made in between 08.40 hrs to 09.45hrs) I arrested the lady after maintaining all formalities in presence of lady police personals u/s 41 Cr.pc. and issued Memo of arrest appraising the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Parboti Dubey-37yrs w/o Lt Raj Kumar Dubey of Santoshinagar, Near Santoshi Mandir, ward No-V, PS Siliguri Dist Darjeeling under proper section of law and arrange for investigation..
