Sir,

In producing herewith arrested accused person namely Shefali Roy (44) D/O Late Bhabesh Roy of Promod Nagar , Ward No. 18, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 33 (thirty three) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 50 each (Amounting of 33 x Rs 50/- =RS.1650/-), ii) 10 sealed bottles of Kingfisher Strong Premium containing 650 ml each amounting of Rs. 130x10 =Rs. 1300/-, iii) 05 sealed bottles of Imperial blue whiskey containing 180 ml amounting of Rs. 174x5 = Rs. 870/-, iv) 05 sealed bottles of McDowell No.1 whiskey containing 180 ml each amounting of Rs. 174/05 = Rs/ 870/-, v) 04 sealed bottles of Sterling Reserve whiskey containing 180 ml each amounting of Rs. 204x04 = Rs.816 and vi) 07 sealed bottles of McDowell celebration Rum containing 180 ml each amounting of Rs. 153 x07 = Rs.1071/- (Total amount of Rs. 6577/-) as per seizure list.

I, ASI Siben Sarker of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Shyafali Roy (44) D/O Late Bhabesh Roy of Promod Nagar , Ward No. 18, PS- Siliguri, Dist- Darjeeling to the effect that on 19.06.21 at 08.05 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at her house situated at Promod Nagar , Ward No. 18 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 1152 dated 19.06.21 and informed the fact to I/C Siliguri PS. As per his direction of I/C Siliguri PS, I along with ASI Subir Sen, LC/1210 Nilam Chhetri , LC/1272 Prakriti Gholay and CV/283 Prosenjit Dey and left Promod Nagar , Ward No. 18 Siliguri PS vide Siliguri P.S GDE NO: 1153 dated 19.06.21 to verify the veracity of the information. On reaching at 08.25 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person

tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, the above noted person disclosed her identity as noted above. On searching we found i) 33 (thirty three) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 50 each (Amounting of 33 x Rs 50/- =RS.1650/-), ii) 10 sealed bottles of Kingfisher Strong Premium containing 650 ml each amounting of Rs. 130x10 =Rs. 1300/-, iii) 05 sealed bottles of Imperial blue whiskey containing 180 ml amounting of Rs. 174x5 = Rs. 870/-, iv) 05 sealed bottles of McDowell No.1 whiskey containing 180 ml each amounting of Rs. 174/05 = Rs/ 870/-, v) 04 sealed bottles of Sterling Reserve whiskey containing 180 ml each amounting of Rs. 204x04 = Rs.816 and vi) 07 sealed bottles of McDowell celebration Rum containing 180 ml each amounting of Rs. 153 x07 = Rs.1071/- (Total amount of Rs. 6577/-) which was kept concealed in her house. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since last ten (10) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 08.45 hrs to 09.50 hrs. On being asked he stated that she used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Shefali Roy (44) D/O Late Bhabesh Roy of Promod Nagar , Ward No. 18, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigate.
