dt. 20.06.2021 at about 10:00 am, when my old aged  
father namely, Abdul Aziz (60 yrs approx) Late  
Abdul Aziz of above noted address reached at  
Burdwan Road, (Near Zaika) on his bi-cycle,  
at that time, the unknown driver of the four  
wheeler, bearing Regd. No. WB-73-E-5396,
