Sir,

In producing herewith one accused person namely Krishna Gurung (48) S/O Lt. Jagat bahadur Gurung of Farabari, Nepalibusty PS- NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. One (01) Bottle of Mc Dowells no.01 superior whisky Original 750 ml
2. One (01) Bottle of Mc Dowells no.01 Luxary Premium whisky 750 ml
3. One (01) Bottle partially filled of Mc Dowells no.01 superior whisky Original.
4. One (01) Bottle Mc Dowells no.01 Celebration Matured XXX RUM 750 ml.
5. One (01) Bottle partially filled Mc Dowells no.01 Celebration Matured XXX RUM.
6. Six (06) Bottle of Kingfisher Strong Premium beer 650 ml each.
7. Two (02) Pouch Of Officer's Choice Deluxe Whisky 180 ml each.

I, SI Rakesh Debnath of Ambari Falakata out post under NJP PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 18.06.2021 at 15.45 hrs received a source information that at the house of Krishna Gurung (48) S/O Lt. Jagat bahadur Gurung of Farabari, Nepalibusty PS- NJP Dist- Jalpaiguri has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata out post GDE no-680 dated 18.06.21. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, CVF/963 Tapan Roy, CVF/001 Jay Chand Roy, CVF/483 Khirmohan Roy proceed to Nepalibusty to work out the information. At 16.15 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Krishna Gurung and recovered the above noted articles from the possession of above noted accused person namely Krishna Gurung (48) S/O Lt. Jagat bahadur Gurung of Farabari, Nepalibusty PS- NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit, Majumdar S/o Lt. Ashim Majumdar of Chakiavita, P.O-Kamarvita, Ps-NJP, Dist-Jalpaiguri and 2. Sanjay Rai S/o Lt. Adil Man Rai Of Farabari, Nepalibusty PS- NJP Dist- Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 16.45 hrs to 17.05 hrs. Therefore, I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Krishna Gurung (48) S/O Lt. Jagat bahadur Gurung of Farabari, Nepalibusty, PS- NJP Dist- Jalpaiguri under proper section of law.
