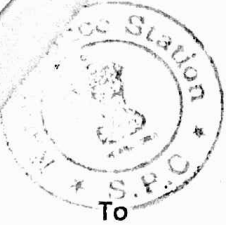

 Sir,

In producing herewith one Lady accused namely Kamona Sarkar (21) W/o parimal Mandal of Dakshin Vivekananda Pally, P.o-Vivekananda Pally, PS- Kotwali, Dist- Jalpaiguri at present rented house of Sabani Mandal of Nataji Para, Dabgram, P.o-Ghugumali, Ps-Bhaktinagar, Dist- jalpaiguri along with the following seized articles as per proper seizure list:

- (i) 30 (Thirty) bottles of Pet Galaxy Boss 60° UP Country Spirit 300 ml. each.
- (ii) One nylon carry bag in which the said liquor has been kept.

I, ASI Md. Jamirul Haque of Ambari Falakata out post under NJP PS, SPC, lodged a written complaint against the above noted person to the effect that today i.e. on 20.06.2021 at 15.05 hrs received a source information that one lady sells illicit liquor beside road at Jaldumur para, Sahudangi hat in the local customer for her wrongful gain. This refers to Ambari Falakata out post GDE no-769 dated 20.06.21. Then, I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, ASI Kajal Chakraborty, L/C 741 Mallika Roy, C/343 Shyamal Roy and HG/749 Nripendra Nath Sarkar proceed to Bakuabari to work out the information. At 15.45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Jaldumur Para and recovered the above noted articles from the possession of the above noted accused person namely Kamona Sarkar (21) W/o parimal Mandal of Dakshin Vivekananda Pally, P.o-Vivekananda Pally, PS- Kotwali, Dist- Jalpaiguri. On demand she could not produce any valid license/documents in support of the said liquor. She become nervous and admitted her guilt before us and stated that she sells the same in the customer since long for her wrongful gain. In presence of witnesses namely 1) Subhas Sarkar S/o Lt Narayan Sarkar of Mahamaya colony PS-NJP Dist-JPG. 2) Rabi Thapa S/O Ramesh Thapa of Durgaguri, PS-Pradhanagar Dist-Darjeeling, I have seized the above noted articles from the possession of the above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 16.35 hrs to 16.55 hrs. Therefore, finding no other alternatives I have arrested the said accused person u/s 41 Cr.P.C. for compel her presence in the Ld. Court and issued Memo of arrest appraising the ground of arrest in presence of the witnesses.

Hence, I request you a specific case may kindly be started against the accused person namely Kamona Sarkar (21) W/o parimal Mandal of Dakshin Vivekananda Pally, P.o-Vivekananda Pally, PS- Kotwali, Dist- Jalpaiguri under proper section of law.
